

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: MINUTES OF MEETING HELD
THURSDAY, APRIL 13, 1995

On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

On this date, the County Commission, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, approved minutes from Thursday, April 6, 1995.

On this date, the County Commission approved Personal Property Improvers for Measuregraph Company - Vienna District and Dale R. Stewart - City District. The County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, did hereby ORDER that a list of personal property tax tickets be impropered. Such list was compiled by the Sheriff's Tax Office and received approval from the Assessor of Wood County, S.F. Greiner. This list of tax tickets to be impropered is attached to these minutes and should be made a part thereof. An Order was prepared regarding this matter.

At 9:30 A.M., the County Commission met with Toni Tiano and Tim Knopp, grant consultants for Wood County. Mr. Knopp first discussed the Y.I.E.L.D. Grant. The County Commission of Wood County, upon a motion made by Holmes R. Shaver, seconded by Steven A. Grimm and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Preapplication requesting funding in the amount of fifteen thousand forty-eight

dollars (\$15,048.00) from the Juvenile Justice and Delinquency Prevention Program Grant. Approval of such Preapplication would allow the Y.I.E.L.D. (Youth in Effective Legal Diversion) Program to continue in Wood county. The Project period would commence on September 1, 1995 and continue through August 31, 1996. The said Y.I.E.L.D. Program establishes an educational and supportive framework for incorrigible youth and their parents, and would continue to be managed and supervised through the Juvenile Probation Office for Wood County. The said Juvenile Justice and Delinquency Prevention Program funding is through the Governor's Committee on Crime, Delinquency and Correction, Charleston, West Virginia. Matching funds in the amount of eighteen thousand dollars (\$18,000.00) would be provided through in-kind services and personnel costs from the Probation Office, Prosecuting Attorney's Office, Law Enforcement Agencies, Counseling Agency, Social Services Agencies, etc. An Order was prepared regarding this matter.

The second grant that Mr. Knopp discussed was in regard to an after care program for juveniles. The County Commission of Wood County, upon a motion made by Holmes R. Shaver, seconded by Steven A. Grimm and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Preapplication requesting funding in the amount of twenty-five thousand dollars (\$25,000) from the Juvenile Justice and Delinquency Grant. Approval of such Preapplication would establish an after care program for juveniles through a Specialized Case Manager that would be managed and supervised by the Juvenile Probation Office for Wood

County. A Specialized Case Manager, working on a contractual basis, would become involved in a juvenile's case approximately ninety (90) days before the expected discharge and would continue working with the said juvenile approximately thirty (30) days following discharge. The Grant period would commence on September 1, 1995 and would continue through August 31, 1996. The said Juvenile Justice and Prevention Program funding is through the Governor's Committee on Crime, Delinquency and Correction, Charleston, WV. Matching funds in the amount of six thousand dollars (\$6,000.00) would be provided through office space, utilities, use of computer, secretarial assistance, etc. of the Juvenile Probation Office of Wood County. The said Preapplication and all supporting documentation pertaining to the said Juvenile Justice and Delinquency Prevention Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The third item that Mr. Knopp discussed was the Agreement between Kim Alexander and the County Commission. Ms. Alexander was injured by a drunk driver and is now confined to a wheelchair and now does speaking in regard to what happened to her. The County Commission of Wood County, upon a motion made by Holmes R. Shaver, seconded by Steven A. Grimm and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Agreement by and between the County Commission of Wood County and Kim Alexander. Ms. Alexander of Salem, South Carolina, is a highway safety presenter who will be making highway safety presentations at Parkersburg High School,

Parkersburg South High School, Belpre High School, Parkersburg Catholic High School, Williamstown High School and Warren High School the week of May 8, 1995. The purpose of such presentations is to provide activities to enhance the understanding and awareness of young people about highway safety and the dangers associated with drunk and drugged driving and related issues. Ms. Alexander will be compensated in the amount of three thousand dollars (\$3,000.00) and her mother will be compensated in the amount of five hundred dollars (\$500.00) from Grant funds. All documentation pertaining to the said State of West Virginia Department of Military Affairs and Public Safety-Criminal Justice and Highway Safety Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The next matter Mr. Knopp discussed was a letter to Mr. James Grate of the Criminal Justice and Highway Safety Office. The County Commission of Wood County, upon a motion made by Holmes R. Shaver, seconded by Steven A. Grimm and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the letter addressed to the Criminal Justice and Highway Safety Office, Charleston, West Virginia, which serves as an application for an additional ten thousand dollars (\$10,000.00) from the Section 402 General Highway Safety Account. The above-stated funding was originally requested in the County's grant application dated July 21, 1994; however, was not funded at that time. Due to additional grant funds being available at the State level, the County Commission is again submitting a request for such grant funds. If

approved, funding in the above-stated amount would be used for overtime compensation by the Wood County Sheriff's Department, the City of Parkersburg's Police Department and the City of Vienna's Police Department. Traffic and speed enforcement activities will be conducted by the above-stated law enforcement agencies on roads which will include I-77, Route 50, Route 2, Route 14, Murdoch Avenue, Garfield/Ohio Avenue and Grand Central Avenue. All documentation pertaining to the said Highway Safety Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The last item that Mr. Knopp wished to discuss was the Offender Treatment Program being administered by the Adult Probation Office. The present counselor Bridgett Reger is expecting a child at any moment; there are only three months of counseling services left so they need to replace her; this is the last year of this grant. The County Commission agreed that they should find someone to replace her.

At 10:00 A.M., the County Commission held a hearing for the Jennie Agnes Schmidt estate. Attorney Thomas Zimmerman represented one of the heirs who wanted the estate referred to a Fiduciary Commissioner. However, Attorney George Cosenza had asked Mr. Zimmerman to continue this hearing. The County Commission, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, continued this hearing until April 24, 1995 at 11:00 A.M.

At 10:30 A.M., the County Commission met with Toni Tiano and Tim Knopp again, as well as Sergeant Bill Kelley from the Beckley Police

Department, Dave Dickens, Charleston Police Department, Chief Gary Deem, Vienna Police Department, Chief Charlie Johnson, Wood County Sheriff's Department, Mark Rhodes, Jail Administrator for Wood County Correctional Center. Mr. Kelley stated they like to get as many agencies as possible to participate in the CLAWS; law enforcement is information type of organization and need to share information; CLAWS (Combined Local Agency Warrant System) is a network of computer systems that are put in police departments throughout the state to tie them together to share information; a lot of what they have done has been through Highway Safety Grants as well as funding from other law enforcement agencies; Wood County and Vienna have inquired about how they could participate in the program; in this area Parkersburg is a "hub site" which has the large computer system that acts as the central hub, then other agencies tie in as "nodes"; the hub site has to bear the brunt of the costs of maintaining the system plus have someone to function as system administrator to maintain the system; the node agencies don't have such a significant cost; the County would have to have Novell Network software to tie into a Unix system; there would be an annual maintenance cost; they usually prorate the cost for the nodes based upon how much of the system they think that they will use; that would have to be worked out between the City of Parkersburg and the County; there will be costs throughout the coming years. Commissioner Grapes asked how it actually works. Mr. Kelley stated there is a crime module which keeps lists of criminal arrests, warrants, calls for service, etc. so that when an officer has a contact with someone that he feels is suspicious, he can collect

information on the person; the officer can also find out if a person is wanted through a warrant by any other agency. Mr. Kelley feels that this would be used everyday; CLAWS is not owned by anyone, it is governed by a representative from each hub agency and a representative elected by all of the member node agencies, all decisions are then made by a board of directors; they have a set of by laws and rules as well as an agreement that each agency needs to sign. Annual maintenance costs would be \$2600.00 as well as a fee to the City of Parkersburg. More discussion took place. Mr. Kelley stated that the money from the Grant to help law enforcement agencies with the CLAWS program needs to be expended by the end of the grant period. The Commission stated that they would discuss this matter and be in touch with them.

On this date, the County Commission met with Michele Rusen, Prosecuting Attorney in regard to the College View Road Maintenance Association. Ms. Rusen stated that they cannot put this on hold as requested by some homeowners due to the law changing (the bill was signed in March and becomes effective 90 days later) because you have to go by the law that was in effect at the time this was done. Commissioner Grapes stated that the two objections the Commission received were not objectible. The County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, gave Approval to the Petition for the creation of the College View Road Maintenance Association in accordance with Chapter 7, Article 12A, Section 1, et seq. of the West Virginia Code of 1931, as amended. Objections to the formation of such road maintenance

association were expressed during a Public Hearing before the County Commission on Monday, April 10, 1995. However, the County Commission did hereby find that owners of sixty percent (60%) of the frontage on the roads have requested, by the signing of a petition, the establishment of such a road maintenance association and that property notice, as required by law, was given. Therefore, the County Commission did hereby ORDER that the Petition for the creation of the College View Road Maintenance Association be approved. Commissioner Holmes R. Shaver abstained from voting due to the fact he was not present during the Public Hearing at 10:00 A.M. on Monday, April 10, 1995. An Order was prepared regarding this matter.

On this date, and pursuant to an Order appearing in Order Book 51, at Page 433 and bearing the date of April 1, 1991, dealing with the procedure policy for appointments to Boards and Authorities, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and made unanimous by Jean Grapes, appointed Robert Cordell to the Wood County Planning Commission. The vacancy was announced on December 1, 1994 as a result of Ferris Nedeff no longer wishing to be a member on said Commission. Mr. Cordell was placed in nomination on April 6, 1995, his term will expire on December 31, 1997. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Request for

Reimbursement in regard to the Drug Control and System Improvement Grant Number 94-DC-049. Expenditures in the amount of one thousand twenty-nine dollars (\$1,029.00) were made by the County during the month of March, 1995 which represents payment of contractual services provided by counselors for adult offenders who have drug and/or alcohol abuse substance problems. Said program is being provided through the Wood County Adult Probation Office. However, the Request for Reimbursement is in the amount of nine hundred twenty-six dollars and ten cents (\$926.10) since there is a ten percent (10%) matching fund requirement set forth in the said Grant to be met by the County. In addition to the Request for Reimbursement, the Monthly Progress Report and the Project Financial Report are being submitted to the Criminal Justice and Highway Safety Office, Charleston, West Virginia. All documentation pertaining to the said Drug Control and System Improvement Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Progress Report for the month of March, 1995 in regard to the Juvenile Justice and Delinquency Prevention Grant Number 94-JJ-3-004. The said Progress Report is being submitted to the Criminal Justice and Highway Safety Office, Charleston, WV. All documentation pertaining to the said Juvenile Justice and Delinquency Prevention Grant is on file in the Office of the County Administrator. An Order was prepared regarding

this matter.

On this date came Robert W. Full, attorney for Arthur R. Cooper, dba Community antenna Service and tendered an application of the said Arthur R. Cooper for renewal of his franchise to operate the business of a cable television system in the unincorporated areas in Wood County, together with the franchise fee of \$250.00, as required by law, and further moved the Commission to set a public hearing on said application and to renew such franchise for a period of between five and twenty years upon such terms as set forth by West Virginia Code Sections 5-18-1 et seq. and the rules and regulations of the West Virginia Cable Television Advisory Board. The County Commission Ordered that said application is accepted for filing and hereby Ordered filed. It is further Ordered that said application cause notice of such public hearing to be published as a Class II legal advertisement in a newspaper of general circulation in Wood County. It is further Ordered that said application file a copy of said petition, together with a copy of the notice of public hearing and a copy of the Order with the West Virginia Cable Television Advisory Board. Said Order was signed by Jean Grapes, President of the Wood County Commission. Said Public Hearing will be held Monday, May 22, 1995.

On this date, the County Commission of Wood County, upon a motion made by Holmes R. Shaver, seconded by Steven A. Grimm and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Prohibition of the Use of Federal Funds For Lobbying Certification, to sign the

Certification and Assurance to Accompany the Emergency Shelter Grants Program Application and to sign the Emergency Shelter Grants Program Certification by Chief Executive Officer on behalf of the Family Crisis Intervention Center in regard to their application for funding from the Emergency Shelters Program being administered through the Office of Economic Opportunity Office, Charleston, West Virginia. The County Commission of Wood County does support and does endorse the Application for the West Virginia Homeless Shelters Program submitted by the Family Crisis Intervention Center. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of the Statement of Account from WesBanco Wheeling, Wheeling, WV, for the three-month period ending March 31, 1995 in regard to the Federal Land Book Notes in the amount of fifty thousand dollars (\$50,000.00), cusip number 901178BT9, at 7.95% and due on October 21, 1996. The said WesBanco Wheeling has pledged the above-stated amount to the County Commission of Wood County as a County Depository. All documentation pertaining to County Depositories is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of the Statements of Accounts for the Mortgage Reserve Fund and the Expense Fund from Bank One, Charleston, West Virginia, in regard to the Brooke, Harrison, Marshall, Wetzel and Wood Counties, West Virginia Single Family Mortgage Revenue Refunding Bonds Series 1992. The said Statements of Accounts are for the period of January

1, 1995 through March 31, 1995. All documentation pertaining to the said Single Family Mortgage Revenue Refunding Bonds is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of the Statement of Account from Bank One, Charleston, West Virginia, in regard to the Brooke, Harrison, Marshall, Wetzel and Wood Counties, West Virginia Single Family Mortgage Revenue Refunding Bonds, Series 1992. The said Statement of Account is for the period of April 1, 1994 through March 31, 1995. All documentation pertaining to the said Single Family Mortgage Revenue Bonds is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of the Statements of Accounts for the Deposit Fund, the Reserve Account Fund and Fund 3 and 9 from United National Bank, Parkersburg, WV, in regard to the Wood County, Building Commission (Wood County Courthouse Annex Project) 1983 Series Bond Issue. The said Statements of Accounts are for the period of January 1, 1995 through March 31, 1995. All documentation pertaining to the said Statements of Accounts is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of the Statements of Accounts for the Repair Fund and the Revenue Fund from United National Bank, Parkersburg, West Virginia, in regard to the Wood County, West Virginia Industrial Development

Revenue Bonds 1980 Series A (Kroger Company Project). The said Statements of Accounts are for the period of January 1, 1995 through March 31, 1995. All documentation pertaining to the said Industrial Development Revenue Bonds is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of the Statement of Assets for the Debt Service Fund and the Debt Service Reserve Fund from Commercial Banking and Trust Company, Parkersburg, West Virginia in regard to the Wood County Building Commission Revenue Refunding Bonds Series 1990 (St. Joseph's Hospital). The said Statement of Assets is for the period ending March 31, 1995. All documentation pertaining to the said Revenue Refunding Bonds is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of the Statement of Assets for the Debt Service Account Fund, the Debt Service Investment Account Fund, the Debt Service Reserve Account Fund and the Depreciation Reserve Fund from Commercial Banking and Trust Company, Parkersburg, West Virginia, in regard to the Wood County Building Commission Revenue Refunding Bonds Series 1984 (St. Joseph's Hospital). The said Statement of Assets is for the period ending March 31, 1995. All documentation pertaining to the said Revenue Refunding Bonds is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of the Statements of Accounts for the Cost of Issuance

Account Fund, the Escrow Account Fund and the Escrow Account - Expense Fund from One Valley Bank, Charleston, West Virginia in regard to the Wood County, West Virginia Single Family Mortgage Revenue Refunding Bond Issue, Series 1991A. The said Statement of Account for the Cost of Issuance Fund is for the period of February 28, 1995 through March 31, 1995 and the said Statements of Accounts for the Escrow Account Fund and the Escrow Account - Expense Fund are for the period of September 30, 1994 through March 31, 1995. All documentation pertaining to the said Single Family Mortgage Revenue Refunding Bond Issue is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, was in receipt of the Statements of Accounts for the Redemption Fund, the Excess Earnings No. 2, the Revenue Fund, the Prepayment Account Fund, the Acquisition Fund, the Program Expense Fund, the Excess Investment ER Fund, the Debt Service Reserve Fund, the Mortgage Reserve Fund and the Debt Service Fund from One Valley Bank, Charleston, West Virginia, in regard to the Counties of Berkeley, Brooke, Fayette, Hancock, Harrison, Jackson, Jefferson, Marion, Marshall, Mason, Mercer, Monongalia, Morgan, Nicholas, Ohio, Raleigh, Randolph, Upshur, Wetzel and Wood and the City of Wheeling, West Virginia Single Family Mortgage Revenue Bonds, 1984 Series A. The said Statements of Accounts are for the period of September 30, 1994 through March 31, 1995. All documentation pertaining to the said Single Family Mortgage Revenue Bonds is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

In accordance with the provisions of Article 8, Section 11, of the West Virginia Code, as amended, this day the County Commission of Wood county received Notice of a Conditional Approval of the Levy Estimate (Budget) from the State Tax Commissioner approving the Levy Estimate (Budget) as the operation budget for the Fiscal Year beginning July 1, 1995 through June 30, 1996. NOTICE OF A CONDITIONAL APPROVAL OF THE LEVY ESTIMATE (BUDGET)
TO: Wood County Commission

In accordance with the provisions of Chapter 11, Article 8, of the West Virginia Code, as amended, the State Tax Commissioner of West Virginia hereby approves your Levy Estimate (Budget) for the fiscal year beginning July 1, 1995.

I find that any levy rates to be imposed in excess of those prescribed by the West Virginia Constitution were legally authorized by a vote of the people.

I find that the proper rates of levy are being used to retire an existing general obligation bond debt, and that such total debt is within the limits prescribed by the West Virginia Constitution and Code.

HOWEVER, THE FOLLOWING COMMENTS ARE MADE BASED ON AN AUDIT AND REVIEW OF THE BUDGET DOCUMENT BY THIS OFFICE.

Please separate the revenue for Service of Process (account # 313-01) from the total of the Sheriff's Earnings (account # 313).

With this written approval, the levying body shall meet on the third Tuesday in April to hear and consider any objections and to officially adopt the levy rates for property taxation. The clerk/recording officer, within three days, shall prepare and forward to the tax commissioner the officially adopted levy rates and levy order.

Please take whatever corrective action is necessary to remedy these problems and notify this office of your intentions.




