

IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: MINUTES OF MEETING HELD
THURSDAY, MAY 25, 1995

On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

On this date, the County Commission, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and made unanimous by Jean Grapes, approved minutes from Thursday, May 18, 1995 and Monday, May 22, 1995.

On this date, the County Commission, upon a motion duly made, seconded and passed, Ordered that the Order appearing in Order Book 56, at Page 237 and bearing the date of May 11, 1995 be Voided. Said Order is in regard to the receipt of a check from the State of West Virginia in the amount of \$1,303.35, of which the amount of \$543.35 represents reimbursement to Wood County for overtime compensation during the month of March, 1995 paid to Sgt. Donald G. Balog of the Wood County Sheriff's Department who has been assigned as the officer to work the D.A.R.E. Program for Wood County under the Drug Control and System Improvement Grant Number 94-DC-023. An Order was prepared regarding this matter.

On this date, the County Commission, upon a motion duly made, seconded and passed, Ordered that the Order appearing in Order Book 56, at Page 237 and bearing the date of May 11, 1995 be Voided. Said Order is in regard to the receipt of a check from the State of West

Virginia in the amount of \$1,303.35, of which the amount of \$760.00 represents reimbursement to Wood County for payment of contractual group counseling services provided by Fred J. Krieg, Ph.D. and Associates in regard to the Juvenile Justice and Delinquency Prevention Grant Number 94-JJ-7-013. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of a check in the amount of one thousand three hundred three dollars and thirty-five cents (\$1,303.35) from the State of West Virginia, of which the amount of five hundred forty-three dollars and thirty-five cents (\$543.35) represents reimbursement to Wood County for overtime compensation during the month of March, 1995 paid to Sgt. Donald G. Balog of the Wood County Sheriff's Department who has been assigned as the officer to work the D.A.R.E. Program for Wood County under the Drug Control and System Improvement Grant Number 94-DC-023. Receipt of said check is pursuant to an Order appearing in Order Book 56, at Page 225 and bearing the date of April 24, 1995 at which time the Request for Reimbursement was signed by Jean Grapes, President of the Wood County Commission. All documentation pertaining to the said Juvenile Justice and Delinquency Prevention Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of a check in the amount of one thousand three hundred three dollars and thirty-five cents (\$1,303.35) from the State of West Virginia, of which the amount of seven hundred sixty dollars (\$760.00) represents

reimbursement to Wood County for payment of contractual group counseling services provided by Fred Jay Krieg, Ph.D. and Associates in regard to the Juvenile Justice and Delinquency Prevention Grant Number 94-JJ-7-013. Receipt of said check is pursuant to an Order appearing in Order Book 56, at Page 205 and bearing the date of March 23, 1995 at which time the Request for Reimbursement was signed by Jean Grapes, President of the Wood County Commission. All documentation pertaining to the said Juvenile Justice and Delinquency Prevention Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Request for Reimbursement in regard to the Drug Control and System Improvement Grant Number 94-DC-057. Expenditures for the salary of C. Scott Durig, Assistant Prosecuting Attorney, were in the amount of three thousand three hundred seventy-five dollars (\$3,375.00), plus the amount of benefits, which includes social security, health insurance, retirement and workers' compensation during the month of April, 1995. However, the Request for Reimbursement is in the amount of four hundred forty dollars (\$440.00) which represents compensation at sixteen dollars (\$16.00) per hour, the allowable compensation under the said Grant, for 27.50 hours allocated to the duties of the Drug Prosecutor by Assistant Durig as defined and set forth in the said Grant. In addition to the Request for Reimbursement, the Monthly Progress Report

and the Project Financial Report are being submitted to the Criminal Justice and Highway Safety Office, Charleston, West Virginia. All documentation pertaining to the said Drug Control and System Improvement Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, authorized Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Request for Reimbursement in regard to the Juvenile Justice and Delinquency Prevention Grant Number 94-JJ-7-013. Expenditures in the amount of five hundred twenty dollars (\$520.00) were made by the County during the month of April, 1995 for contractual group counseling services provided by Fred Jay Krieg, Ph.D. and Associates in regard to the Youth in Effective Legal Diversion (Y.I.E.L.D.) Program. In addition to the Request for Reimbursement, the Monthly Progress Report and the Project Financial Report are being submitted to the Criminal Justice and Highway Safety Office, Charleston, West Virginia. All documentation pertaining to the said Juvenile Justice and Delinquency Prevention Grant are on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Jean Grapes and passed, adopted a Resolution in reference to Budget Revision No. 26 in the General County Fund budget for the fiscal year 1994/1995. The Request for Revision to the Approved Budget, being submitted to the Department of

Tax and Revenue, Charleston, West Virginia, was signed by Jean Grapes, President of the Wood County Commission. An Order was prepared regarding this matter.


Having no further scheduled appointments or business to attend to, the County Commission adjourned at 12:00 Noon.
