At 2:15 P.M., the Board met with James Sharp - Walker District - Map 100, Parcel C.


At 2:30 P.M., the Board met with Robert W. Bailey - Lubeck District - Map 70, Parcel L.




Having no further scheduled appointments or walk-ins, the Board of Review and Equalization adjourned at 3:30 P.M.
