The term of the lease is for a period of one year beginning March 1, **∜1996 and ending on February 28, 1997 and the rental is in the amount** of one dollar and 00/100ths cents (\$1.00) payable annually on or efore the first day of March of each year in which the Lease is in #xistence. Maintenance and utility costs are to be paid by the said Westbrook Health Services, Inc. along with an insurance policy of comprehensive public liability insurance and property damage in which the limits of coverage for bodily injury shall not be less than five undred thousand dollars and 00/100ths cents (\$500,000.00), combined single limits and in which the coverage for property damage shall not be less than three hundred thousand dollars and 00/100ths cents \$300,000.00), per accident and the property shall be insured against perils of all risks in the amount of one hundred thousand dollars and 0/100ths cents (\$100,000.00). An Order was prepared regarding this hatter.

On this date, the County Commission of Wood County, upon a motion made by Steven A. Grimm, seconded by Holmes R. Shaver and passed, did mereby AUTHORIZE Jean Grapes, in her official capacity as President and on behalf of the County Commission, to sign the Request for Reimbursement in regard to the Drug Control and System Improvement Grant Number 95-DC-025. Expenditures in the amount of eight hundred twenty-four dollars and eighty cents (\$824.80) were made by the County during the month of January, 1996 which represents overtime compensation for Sqt. Donald G. Balog and Deputy Carl VanClief of the

wood county Sheriff's Department who have been assigned as the officers to work the D.A.R.E. (Drug Abuse Resistance Education) Program for Wood County. However, the Request for Reimbursement is in the amount of seven hundred forty-two dollars and thirty-two cents \$742.32) since there is a ten percent (10%) stipulation in the said Grant that requires the said percentage from the County as matching funds.
