IN RE: MINUTES OF MEETING HELD
FRIDAY, MAY 17, 1996

At 8:30 A.M., the County Commission met in Special Session, sitting ex-officio as a Board of Canvassers.

The Commission sat as the Board to canvass and ascertain the results of the Primary Election held on May 14, 1996. Also present were Jamie Six, Clerk of the County Commission; Mary R. Others observing the canvassing were Stephen Greiner, Wood County Assessor; Brett Dunlap and Pam Brust, employees of The Parkersburg News & Sentinel. The ballots, poll books, tally sheets and certification of the various voting places were placed before the Board of Canvassers. The County Commission went through the challenged ballots for precincts 1 through 36A.

At 11:45 A.M., the Commission adjourned said Special session

until Monday, May 20, 1996 at 8:00 A.M.

At 1:30 P.M., they reconvened and went through the challenged ballots for Precinct 62 through 87.


The ballots, having been completed, were counted again.

The County Commission adjourned at 5:00 P.M. and will reconvene at 8:55 A.M. on Tuesday, May 21, 1996.
