At 8:00 A.M., the County Commission met in regular session, sitting ex-officio as a Board of Canvassers. Commissioner Grimm was present but did not participate.

The ballots, poll books, tally sheets and certification of the various voting places were placed before the Board of Canvassers. The County Commission went through the challenged ballots for precincts 36B through 61.

At 11:50 A.M., they broke for lunch.

At 1:30 P.M., they reconvened and went through the challenged ballots for Precinct 62 through 87.


The ballots, having been completed, were counted again.


The County Commission adjourned at 5:00 P.M. and will reconvene at 8:55 A.M. on Tuesday, May 21, 1996.
