IN RE: MINUTES OF MEETING HELD  
WEDNESDAY, MAY 22, 1996

At 8:30 A.M., the County Commission met in Special Session, sitting ex-officio as a Board of Canvassers.

The Commission sat as the Board to canvass and ascertain the results of the Primary Election held on May 14, 1996. Also present were Jamie Six, Clerk of the County Commission; Jay Day, Administrative Assistant in the County Clerk's Office; Angela Black, Secretary of the County Commission; Kay Williams, Barbara Darnold, Joy Jobs, Dorothy Turner, Donna Lucas, Melody Woollard, Phyllis Williamson and Brenda Lambert from the County Clerk's Office; Connie Shaffer, from the City of Parkersburg and Tessa Miller and Sondi Wallace from the Wood County Assessor's Office; and John Jones, Maintenance Department employee.

The ballots, poll books, tally sheets and certification of the various voting places were placed before the Board of Canvassers. The County Commission observed the handcount of the ballots for Precincts 37, 43, 66, 36A and 52.

It appearing to this Commission that the several challenged ballots, in the various precincts, were probably made, and the challenges were either over-ruled or sustained; and other changes in the tabulation of the voters were altered; and the Canvass having been completed, as required by law, and all tabulation of the results of the Canvass having been completed, and there being no contests pending in said Primary Election, the Commission, as a Board of


Canvassers, does now declare the Canvass closed and the Clerk is directed to certify all the results of said Election to the Secretary of State, Charleston, West Virginia, and to issue Certificates of Election to persons receiving the highest number of votes for the Offices for which the Election was held.


At 12:15 A.M., the Commission adjourned said Special session and will reconvene on Thursday, May 23, 1996 at 8:55 A.M.
