IN RE: MINUTES OF MEETING HELD
TUESDAY, NOVEMBER 12, 1996

At 9:00 A.M., the County Commission of Wood County met in Special Session to meet ex-officio as the Board of Canvassers to canvass the General Election that was held on Tuesday, November 5, 1996.

Carole Jones presented ballots that were postmarked by the deadline. The County Commission, upon a motion made by Holmes R. Shaver, seconded by Jean Grapes and passed, accepted these ballots.

The County Commission drew numbers to decide which precincts would be hand counted. Those drawn were Nos. 15, 71-71U, 74B, 49A and 57A.

The County Commission adjourned at 12:00 Noon for lunch.

The County Commission met again at 1:00 P.M.

Precincts 1 through 67 were completed on this date.

On this date, the County Commission of Wood County, in Special


A list of challenge ballots and the Commission's decision on each one is attached to these minutes and should be made a part thereof.
