At 8:45 A.M., the County Commission of Wood County met Ex-Officio as the Board of Canvassers, to canvass and ascertain the results of the General Election, held on November 5, 1996. Also present was Jamie Six, County Clerk; Kay Williams and Melody Woollard, County Clerk's Office; Angela Black, County Commission's Office and Brett Dunlap and Pam Brust from The Parkersburg News and Sentinel.

At 9:00 A.M., the ballots, poll books, tally sheets and certification of the various voting places were placed before the Board of Canvassers and they proceeded to canvass the election results.

The County Commission, as the Board of Canvassers completed Precincts 67A through 87. This concluded at 10:26.


The challenge ballots were then opened and ran through the tabulator. Eighty-four ballots from Delegate District 8 were added into Precinct 36C. Forty ballots from Delegate District 9 were added into Precinct 47. Two Hundred Thirty-Four ballots from Delegate District 10 were added into Precinct 1. There was a voter turnout of 71.64%.

After not completing said canvass (handcount not completed), the County Commission, upon a motion duly made, seconded and passed, adjourned at 12:00 Noon and will meet again as the Board of Canvassers on Thursday, November 14, 1996 at 8:30 A.M.




