At 3:00 P.M., the Board met with Robert & Sarah Townsend to discuss property in Lubeck District.


At 3:15 P.M., the Board met with Richard A. Gherke to discuss property in Vienna District.

At 3:30 P.M., the Board met with Joe and Linda DeHaven to discuss property in Parkersburg City District.


