On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

On this date, the County Commission approved Erroneous Assessment Applications regarding personal property for: Darrell H. Enoch in Vienna District for 1997 and Bernard Bosley in Tygart District for 1997.

At 9:00 A.M. Guy Lowther met with the Commission to discuss the building.

At 11:00 A.M. Jay Goff, from Legal Services, met with the Commission to discuss offering to employees benefits through pre-paid legal services at a group rate. Pre-paid legal services works much like health insurance only it is for legal services instead of health care.

On this date, the Commission was in receipt of a check in the amount of two thousand four hundred seventeen dollars and sixteen cents (\$2417.16) from the State of West Virginia for Drawdown Number 10 in regard to The Small Cities Block Grant Number 92-DC-54-0001 for the LMH/Hopewell Water Extension Project being completed by the Lubeck Public Service District. An Order was prepared regarding this matter.

On this date, the Commission was in receipt of a check in the amount of six thousand two hundred twenty-three dollars and seventy-seven cents (\$6223.77) from the State of West Virginia. The amount of one thousand ninety dollars and forty-eight cents (\$1090.48) represents

reimbursement to Wood County for expenses incurred during the month of February, 1998, in regard to the Juvenile Justice and Delinquency Prevention Grant Number 96-JJ-Y-064. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of a check in the amount of six thousand two hundred twenty-three dollars and seventy-seven cents (\$6223.77) from the State of West Virginia. The amount of two thousand seven hundred fifty-one dollars and twenty-four cents (\$2751.24) represents reimbursement in regard to the Juvenile Justice and Delinquency Prevention Grant Number 97-JJ-Y-065. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of a check in the amount of six thousand two hundred twenty three dollars and seventy-seven cents (\$6223.77) from the State of West Virginia. The amount of two thousand three hundred eighty two dollars and five cents (\$2382.05) represents reimbursement in regard to the STOP Violence Against Women Grant Number 960VAW-001. An Order was prepared regarding this amount.

On this date, the County Commission was in receipt of a letter from the Governor of West Virginia informing them of the approval of funds in the amount of twenty thousand eight hundred fifty five dollars and 00/100ths cents (\$20,855.00) in regard to the Victims of Crime Act Assistance Grant. An Order was prepared regarding this matter.


On this date, the County Commission was in receipt of a letter from the West Virginia Department of Administration advising the County Commission that Contract of Lease DDHS-105-D96 had been reassigned by the Department of Administration to the Division of Juvenile Services (West Central Regional Detention Center). An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of the Abstracts From The Records of the Commissioner's Orders from the West Virginia Department of Transportation. An Order was prepared regarding this matter.

Having no other scheduled appointments or any further business to attend to, the County Commission adjourned at 4:00 P.M.
