AUTHORIZED the allocation of up to two thousand five hundred dollars and 00/100ths cents (\$2500.00) to be utilized for the improvement of the four(4) ball fields at the Worthington Ball Fields for the Wood County Recreation Commission. An Order was prepared regarding this matter.

At 10:00 A.M., the County Commission interviewed Sherril Sharp.

At 10:30 A.M., the County Commission interviewed Keith Litton.

On this date, the County Commission adopted a Resolution in reference to Budget Revision Number Three (3) in the General County Fund Budget for the fiscal year 1998/1999. An Order was prepared regarding this matter.

On this date, the County Commission announced that a vacancy exists on the Union Williams Public Service District, and placed Harry W. Sweeney in nomination for re-appointment. An Order was prepared regarding this matter.

On this date, the County Commission authorized David A. Couch, as President, to sign a Resolution which states that Donald R. Smith, Director of the Wood County Emergency Services, shall hereby be legally authorized to enter into agreements with the West Virginia Office of Emergency Services for the State and Local Assistance (SLA) Program. An Order was prepared regarding this matter.




Having no other scheduled appointments or any further business to attend to, the County Commission adjourned at 12:00 Noon.
