On this date, the County Commission was in receipt of a Memorandum from WYK Associates, Inc. advising them that due to time required by the process of public notification and abatement of the asbestos materials located in the Core Road School, Schneider Construction Company would perform this work. An Order was prepared regarding this matter.

On this date, the County Commission was in receipt of Grant Adjustment Notice Number Three (3) in regard to the Juvenile Justice and Delinquency Prevention Grant Number 97-JJ-Y-065. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion duly made, seconded and passed, announced to all concerned that they ORDER the Wood County Judicial Building be CLOSED and VACATED at 4:30 P.M. on Friday, October 16, 1998, to allow for the removal of

old HVAC units located on the roof and further ORDER the Wood County Judicial Building be CLOSED and VACATED at 2:00 P.M. on Wednesday, October 21, 1998, to allow for the installation of the new HVAC unit. An Order was prepared regarding this matter.


Having no other scheduled appointments or any further business to attend to, the County Commission of Wood County adjourned at 12:00 Noon.


