IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: MINUTES OF MEETING HELD THURSDAY, OCTOBER 7, 1999

PRESENT: HOLMES R. SHAVER, PRESIDENT ROBERT K. TEBAY, COMMISSIONER DAVID A. COUCH, COMMISSIONER

On this date, the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

From 9:30 A.M. to 10:00 A.M., the County Commission held interviews for the maintenance position.

At 10:00 A.M., the County Commission held a hearing in regard to the Daniel Moore estate. Information in regard to this hearing is on file in the Probate Office.

At 10:45 A.M., the County Commission met with Lyndall Jones and Leone Ohnoutka from the West Virginia University Extension Office. Ms. Ohnoutka explained the Be Smart, Eat Smart program and a need for office space. A copy of information in regard to this is attached to these minutes and shall be made a part thereof.

The County Commission met with Benny Stump from the Wood County Recreation Commission who presented a list of the expenses and income of the Harvest Moon Festival.

Bevin Seaman and Marlin Sams were sworn in as members of the Wood County Planning Commission.

From 11:00 A.M. to 12:00 Noon, the County Commission held interviews for the maintenance position.

The County Commission of Wood County was in receipt of the GROUP VISION CARE PLAN ADDENDUM from Vision Service Plan Insurance Company, Columbus, Ohio. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by David A. Couch, seconded by Robert K. Tebay and passed, did hereby AUTHORIZE Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Request For Reimbursement in regard to the Juvenile Accountability Incentive Block Grant Number A-D-\$17. Expenditures in the amount of five thousand four hundred sixty-six dollars and five cents (\$5,466.05) were incurred by Wood County during the month of September, 1999. However, the Request For Reimbursement is in the amount of four thousand four hundred twenty-three dollars and fifty-six cents (\$4,423.56) which represents payment of contractual services provided by Larry Johnson, Project R.E.P.A.Y. (Responsibility Enhancement Projects For Adolescent Youth) Director for Wood County, for payment of contractual services provided by Rozann Wilcox, Juvenile Justice Liasion, and further represents payment of travel/training expenses of the aforementioned Project R.E.P.A.Y. Director. A cash match in the amount of one thousand forty-two dollars and forty-nine cents (\$1,042.49) was expended by Wood County which represents the additional two dollars and thirty-eight cents (\$2.38) per hour paid to the Juvenile Justice Liasion by the Office of the Prosecuting Attorney and further represents the full amount of benefits provided to Rozann Wilcox as the Juvenile Justice Liasion. In addition to the Request For Reimbursement, the Monthly Report, the Travel Vouchers, the Financial Recap, the Daily Time Records, the Project Director's Monthly Report, the Monthly Supervisor's Reports, the Demographic Reports and the Project Financial Reports are being submitted to the Criminal Justice Services, Charleston, West Virginia.

Documentation pertaining to the Juvenile Accountability Incentive Block Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by David A. Couch, seconded by Robert K. Tebay and made unanimous by Holmes R. Shaver, did hereby ACCEPT the proposal submitted by John L. Thomas, President, Tri-State Roofing and Sheet Metal Company, Parkersburg, WV, in regard to the repair and/or replacement of roof tiles at the Wood County Courthouse. As proposed by the said Tri-State Roofing and Sheet Metal Company, the cost of the first day would be two thousand six hundred seventy dollars and 00/100ths cents (\$2,670.00) with each subsequent day to be in the amount of two thousand one hundred thirty dollars and 00/100ths cents (\$2,130.00). Commissioner Dave Couch stated that in his conversation with John L. Thomas, that they, Tri-State Roofing and Sheet Metal Company, would check the entire roof of the aforementioned Courthouse for loose-tile replacement and resecurement. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by David A. Couch, seconded by Robert K. Tebay and made unanimous by Holmes R. Shaver, did hereby ORDER that the bid be let for the repair or replacement of the elevator located at the Wood County Courthouse. The Legal Notice will appear in both local newspapers, The Parkersburg News and The Parkersburg Sentinel on Tuesday, October 12, 1999 and on Tuesday, October 19, 1999, with bid opening to be held at 10:00 A.M. on Thursday, November 4, 1999. An Order was prepared regarding this matter.

The County Commission of Wood County ANNOUNCED to all concerned that the closing on the Sid's property would be held on Friday, October 9, 1999. The closing costs are in the amount of three hundred seventy-three thousand one hundred ninety-five dollars and sixty-six cents

(\$373,195.66). The seller of the property shall put the amount of twenty-five thousand dollars and 00/100ths cents (\$25,000.00) in an escrow account for asbestos removal. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion duly made, seconded and passed, placed Jamie Sprague in nomination to fill a vacancy that exists on the Wood County Recreation Commission. Said vacancy is due to the expiration of Steve Swisher's term on September 15, 1999.

Mr. Swisher does not wish to be reappointed. The new term will expire on September 15, 2002.

An Order was prepared regarding this matter.

Mary R. Rader, Director of the Wood County Planning Commission, presented to the County Commission of Wood County a plat of the revised cul-de-sac located on Alpine Street in Alpine Addition, Tygart Taxing District, Mineral Wells, West Virginia. The said Alpine Addition is being developed by David W. Jeffrey and was given final approval by both the Wood County Planning Commission and the County Commission of Wood County in July, 1995. The developer is moving the cul-de-sac, reflected on the original plat of 1995, back approximately seventy-five (75) feet on the existing Alpine Street of the said Alpine Addition. No bond is required since all improvements required by the Subdivision Regulations for Wood County have been met. After review, the County Commission, upon a motion made by David A. Couch, seconded by Robert K. Tebay and passed, did hereby AUTHORIZE Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, to EXECUTE the revised plat for recordation. An Order was prepared regarding this matter.

Having no further scheduled appointments or business to attend to, the County Commission adjourned at 12:00 Noon.

Proposal Wood County, West Virginia

Description of Need:

Wood County is located in the mid-Ohio River Valley on the western edge of West Virginia. Parkersburg, the county seat, is a regional center for communication and business. The county population was estimated at approximately 86,700 for July 1, 1998.

In 1995, it was estimated that 14,524 people of all ages in Wood county were living in poverty. That is 16.5% of the county's population. Of this, 4,985 (34%) were under the age of 18.

In 1998, 4,351 people in Wood County were served by the Women Infant Children Program and as of September 1, 1999, Wood County's food stamp caseload was approximately 4,000.

Evidence of Community Support and Collaboration

Many organizations and agencies in Wood County serve limited resource adults/families. The Super Cupboard Program, sponsored by the twelve Methodist churches that make up Parkersburg Urban Ministries, is designed to give emergency food relief and teach basic living skills to people who utilize emergency food programs on a regular basis. The program provides basic nutrition education. According to Sharon Safstom, Super Cupboard Coordinator, the Be Smart Eat Smart Program would be a natural progression for participants in their program.

According to Annette Gilbert, WIC Director, 4,351 people in Wood County were served through the WIC program and \$1,387,580.00 food dollars were redeemed from WIC vouchers in 1998. Ms. Gilbert felt the "Be Smart Eat Smart" program would be valuable to many WIC clients.

The Wood County Food Cooperative consists of 18 Wood County food pantries operated by local churches. Coop members were supportive of the "Be Smart Eat Smart" program. Many of the people served by the food pantries are in crisis situations. While coop members were unsure if participants would take advantage of the "Be Smart Eat Smart" program, they also had families in mind in their churches that would jump at the chance to participate in such a program.

Beth McNally, Community Resources, Inc., was also very supportive of the program. She was familiar with the "Be Smart Eat Smart" programs in Calhoun and Jackson counties with which her agency had cooperated. She feels there is a strong need for this program in Wood County. In addition, she has a willingness to help with the program in Wood County in any way necessary to implement the program.

Capacity

The Wood County Extension Office is a three agent county. Agents responsibilities are divided as follows: H.R. Scott - Ag and Natural Resources, Lyndall Jones - 4-H and Youth Development, and Leone Ohnoutka - Family Consumer Sciences and Community Economic Development. There are two support staff: Betty Shreve - Administrative Assistant and 4-H Program Assistant, and Judy Lewis, secretary. Adequate resources are available through the Wood County Commission and Wood County Board of Education for office supplies, travel, etc. and the staff feels the office could support a Nutrition Associate.

Following a Wood County Program Review three years ago, the office was charged with increasing programming efforts with limited income families in the county. The staff have made a commitment to this effort. The "Be Smart, Eat Smart" program would reach this clientele within a much needed programming area. Since the current staff has limited nutrition expertise, a nutrition associate would definitely be an asset to the Wood County Extension staff.

All of the organizations/agencies visited with concerning the "Be Smart, Eat Smart" program were anxious to work with the Wood County Extension Service in establishing the program. If selected to participate in the program, several agency representatives would be brought together to plan the focus and initial target audience for the program.

Dear Leona,

I think that the best way to start this letter is to give an overview of what the Super Cupboard Program is about. It is sponsored by 12 Methodist churches in the Parkersburg area-Parkersburg Urban Ministries - as an outreach to low-income individuals. The program was developed by Penn State University several years ago. (see enclosed). We operate our program one day each week from 9:00 - 2:00 for six or seven weeks, and provide transportation and childcare, if needed.

A large part of our program is nutrition and cooking, led by Bettie Lucas and Nancy Morris. We prepare lunch, set the table, eat lunch and clean up together. We try to do recipes that use inexpensive ingredients and on the skill level of the group; sometimes, it must be very basic, other times, we can do more advanced food preparation. Because many don't have basic kitchen equipment, we like to give them measuring cups and spoons, a cutting board, a knife and a casserole dish.

In addition, there are two speakers each week who share information that have been found helpful. The programs that are scheduled for this Fall session (our fifth) are: Marie Weekly from Consumer Credit Counseling; Sally Hannon from the Job Service; Ray Plyes and Bob Haydon will discuss the Adult Education Program, GED and the HRDF program; Cathy Ott from Worthington Center will do a program on Alcohol and Drug Prevention; Pat Mays from the Health Dept will talk about AIDS and answer health-related questions; Jeanne Phillips, from Jefferson Elementary Center will talk about the importance of Parent - School Relations; Tony Tiano from the Neighbor Helping Neighbor Housing Program and Alvin Phillips from Habitat for Humanity will give information about these housing programs. We have left one session open until we see the specific needs of this group and will try to schedule an individual who would be of help to them. Our first session will be a fun one - Alease Goe will lead a class on a simple- to- make basket, which each will take home with them.

Every one involved in the program is a volunteer, except the person in charge of childcare. Funding for our supplies is either donated or from a grant from an arm of the United Methodist Church. Some of our food supplies come off of our Food Pantry Shelves.

The biggest difficulty we have is in getting participants. But those who attend enjoy it greatly and some have asked to attend again. We have a policy that a person can go through it only once. From what I hear of the Be Smart - Eat Smart Program, it would be a natural progression. If there is any duplication at all, it would be reinforcement of good food choices. I see our program as a basic overview of better food choices. For some people, it is enough to

begin to make better food choices; for others, it would take hearing about better nutrition over and over again to make choices that are healthy rather than "like Mom used to cook" or the latest advertized convenience food.

I just heard on the radio the other day that West Virginia is highest in the incidence of osteoporosis. People who don't read newspapers or Health Magazines don't know that! They need to hear from several sources that they can live longer and live better by eating more low fat milk products, 8 to 10 servings of fruits and vegetables, and get more exercise. I'm assuming that is going to be the message of Be Smart-Eat Smart; and that message needs to be presented in a number of ways.



WHAT IS A SUPER CUPBOARD?

A Super Cupboard is a program designed to give emergency food relief and teach basic living skills to people who utilize emergency food programs on a regular basis. The program provides nutrition education, self-esteem building and self-reliance.

The goal of the Super Cupboard is to enable a person to break the cycle of dependency and take steps toward self-sufficiency.

WHO DOES A SUPER CUPBOARD SERVE?

Super Cupboards serve men and women, many of whom are single parents. Because of an emergency situation, they have become frequent users of the food cupboard system.

Super Cupboards are for people who want the chance to make a commitment to permanent self-improvement and move beyond dependence on emergency food. Although encouraged to make this commitment to change, no one using emergency food facilities is required to participate in a Super Cupboard.

HOW DOES A SUPER CUPBOARD RUN?

The Super Cuptoard is set up to run as a weekly series of 5-6 hour classes over a 6-10 week period.

One aspect of nutrition education taught to participants is food preparation and food safety. In addition to learning about food, its use, and healthy preparation, participants discuss topics such as: parenting, income management, job readinest, first aid, self-esteem, home security, drug and alcohol abuse, and domestic violence. By teaching these skills, Super Cupboards cater both to the needs of the individuals and of the community as a whole.

HOW CAN YOUR COMMUNITY BENEFIT FROM SUPER CUPBOARDS?

By offering a Super Cupboard, your community can help to:

- Strengthen the network of social services.
- Reduce the cost of social service programs.
- Educate participants.
- Enable participants to give back to the community.

HOW CAN YOU HELP AS AN INDI-VIDUAL OR AN ORGANIZATION?

Individuals can help by:

- Volunteering time for child care.
- Sharing talents and skills for classes such as home safety or literacy.
