IN RE: MINUTES OF MEETING HELD THURSDAY, SEPTEMBER 9, 1999

On this date, the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

On this date, the County Commission, upon a motion made by Robert K. Tebay, seconded by David A. Couch and passed, approved minutes from November 19, 1998, November 23, 1998, November 30, 1998 and August 16, 1999. The County Commission, upon a motion made by Robert K. Tebay, seconded by David A. Couch and made unanimous by Holmes R. Shaver, approved minutes from July 19, 1999.

On this date, the County Commission approved Erroneous Assessment Applications in regard to Real Property for Melvin D. Maze & Shirley A. & Billy E. Thomas - Slate District (1999); Neely O. & Lora J. Jeffrey - Vienna District (1999); John C. Janes Estate - Walker District (1999) and for Stephen H. & Jeneanne Freed - Union District (1999).

On this date, the County Commission approved Erroneous Assessment Applications in regard to Personal Property for Ronald L. Haught - Williams District (1999); William R. Lyons - City District (1998); Lester W. & Anna Marie Oehlmann - Vienna District (1999); Steven E. Lehew Walker District (1999); Thomas L. & Tressa D. Cochran - Vienna District (1999); Amber R. Kerr - Steele District (1999) and for Mansfield Stealey, III - City District (1999).

At 9:30 A.M., the County Commission met with Charlie Johnson to discuss insurance egarding a new employee. After discussion, the County Commission waived the waiting period for

health insurance for K. Wagner, new employee of the Sheriff's Department who is coming from Vienna Police Department.

At 10:00 A.M., the County Commission met with Ginny Conley, Prosecuting Attorney and D.R. Smith, E-911 Director to discuss the Community Alert Network system. Commission of Wood County, upon a motion made by David A. Couch, seconded by Robert K. Tebay and passed, did hereby AUTHORIZE Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, to EXECUTE the COMMUNITY ALERT NETWORK, NC. GEOGRAPHIC CONTRACT by and between COMMUNITY ALERT NETWORK, INC. and the WOOD COUNTY COMMISSION for the purpose of coordinating a program and service within ts area (Wood County, WV and Washington County, Ohio) that telephone communications to esidents and other identified contacts may be implemented in regard to emergencies and/or disasters in the aforementioned areas. The County Commission of Wood County shall pay Community Alert Network, Inc. fees for its services hereunder the sum of fifteen thousand seven hundred dollars and 00/100ths cents (\$15,700.00) to cover a population base of one hundred fortyeight thousand two hundred fifty-four (148,254) people for the aforementioned area. Washington County, Ohio shall reimburse the County Commission of Wood County half of the aforementioned service costs for their participation in such Program. The County commission of Wood County shall have the right to extend the term of this AGREEMENT for four (4) consecutive one-year periods; for each extension period, the County Commission of Wood County shall pay COMMUNITY ALERT NETWORK, INC. the amount of twelve thousand four hundred seventy hree dollars and 00/100ths cents (\$12,473.00). Here again, Washington County shall reimburse the County Commission of Wood County half of the yearly fee. The aforementioned Agreement may be modified or must be signed by both parties. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by David A. Couch, seconded by Robert K. Tebay and made unanimous by Holmes R. Shaver, did hereby AUTHORIZE D.R. Smith to EXECUTE the COMMUNICATIONS USE AGREEMENT between the WEST VIRGINIA MEDICAL SERVICES TECHNICAL SUPPORT NETWORK, INC. and WOOD COUNTY CENTRAL TELECOMMUNICATIONS CENTER. The said WEST VIRGINIA EMERGENCY MEDICAL SERVICES, TECHNICAL SUPPORT NETWORK, INC. eserves the right to cancel this AGREEMENT upon thirty (30) days written notice to the USER, WOOD COUNTY CENTRAL TELECOMMUNICATIONS CENTER. The WOOD COUNTY CENTRAL TELECOMMUNICATIONS CENTER may terminate this AGREEMENT upon ninety (90) days written notice to the WEST VIRGINIA EMERGENCY MEDICAL SERVICES, FECHNICAL SUPPORT NETWORK, INC. The term of such COMMUNICATIONS USE AGREEMENT is for a period of one (1) year, beginning October 1, 1999 and ending on September \$0, 2000, and shall automatically renew from year to year, unless terminated by WEST VIRGINIA EMERGENCY SERVICES, TECHNICAL SUPPORT NETWORK, INC. An Order was prepared egarding this matter.

At 11:00 A.M., the County Commission met with Mark Lamborn, WV Executive Magazine. Mr. Lamborn discussed putting ads in his magazine. The County Commission will try to set up a meeting on September 16, 1999 or September 23, 1999 with Jim Kinnett, Steve Nicely, Jim Mylott and Ben Garland to discuss this further.

On this date, the County Commission of Wood County, upon a motion made by David A. Couch, seconded by Robert K. Tebay and passed, did hereby AUTHORIZE Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, to EXECUTE the DATA COLLECTION FORMS FOR REPORTING ON AUDITS OF STATES, LOCAL GOVERNMENTS, AND NON-PROFIT ORGANIZATIONS for the fiscal year ending June 30, 1997 and for the fiscal year ending June 30, 1998. The aforementioned DATA COLLECTION FORMS are for the annual audit in regard to Federal Program Awards in the amount of seven hundred ninety-two thousand nine hundred seventy-eight dollars and seventy-seven cents (\$792,078.77) for the fiscal year ending June 30, 1997; and in regard to Federal Program Awards in the amount of six hundred eighty-one thousand three hundred eighty-seven dollars and sixty-five cents (\$681,387.65) for the fiscal year ending June 30, 1998. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by David A. Couch, seconded by Robert K. Tebay and passed, did hereby AUTHORIZE Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Progress Report and The Department Annual Report in regard to the United States Department of Justice, COPS Universal Hiring Program Grant Number 96-UM-WX-1285. The reporting period is January 1, 1997 through December 31, 1997. The aforementioned Progress Report and The Department Annual Report are being submitted to the United States Department of Justice, Vienna, Virginia. Documentation pertaining to the aforementioned COPS Universal Hiring Program Grant son file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County was in receipt of a check in the amount of three thousand two hundred fifty-seven dollars and sixty cents (\$3,257.60) from the State of West Virginia which represents reimbursement to Wood County for expenses incurred during the months of May and June, 1999 in regard to the Combating Underage Drinking Program Grant Number 98-UD-005. Receipt of the aforementioned check is pursuant to an ORDER appearing in Order Book 64, at Page 26 and bearing the date of June 17, 1999, at which time Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, was AUTHORIZED to EXECUTE the Request For Reimbursement for the month of May, 1999; and further pursuant to an ORDER appearing in Order Book 64, at Page 41 and bearing the date of July 12, 1999, at which time Holmes R. Shaver, in his official capacity as President and on behalf of the County Commission, was AUTHORIZED to EXECUTE the Request For Reimbursement for the month of June, 1999. Documentation pertaining to the aforementioned Combating Underage Drinking Program Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

On this date and pursuant to an Order appearing in Order Book 51, at Page 433 and bearing the date of April 1, 1991, dealing with the procedure policy for appointments to Boards and Authorities, the County Commission of Wood County announced to all concerned that a vacancy exists on the Wood County Recreation Commission. Said vacancy is due to the expiration of Steve Swisher's term on September 15, 1999. Mr. Swisher does not wish to be reappointed. The new term will expire on September 15, 2002. An Order was prepared regarding this matter.

Having no further scheduled appointments or business to attend to, the County Commission adjourned at 12:00 Noon.
