On this date, the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

The County Commission approved Erroneous Assessment Applications in regard to Personal Property for Timothy R. & Kimberly J. Toothman - City District (1998); Putnam Leasing & Auto, Inc. - Slate District (1999); James B. & Jo Ellen Lott - Vienna District (1998); Carl Travis - City District (1999) and Debra Rogers - Vienna District (1999). The County Commission approved Erroneous Assessment Applications in regard to Real Property for Jeffrey S. Dowler - City District (1999); Barbara J. Franklin - City District (1999) and for Willie & Ethel Canty - City District (1999).

At 10:00 A.M., the County Commission met with K.D. Merritt, Sheriff to discuss the jail problems.

The County Commission met with Steven A. Grimm, Assessor; Carole Jones, Circuit Clerk and Jamie Six, County Clerk to discuss the new voting (election) system.

Expenditures in the amount of one thousand nine hundred seventy-three dollars and eighty cents \$1,973.80) were incurred by Wood County during the month of December, 1999. The County Commission of Wood County, upon a motion made by David A. Couch, seconded by Robert K. Tebay and made unanimous by Holmes R. Shaver, did hereby ORDER that repairs to the Bell Tower at the Wood County Courthouse, be done on an EMERGENCY BASIS as per the attached letter from Francis A. Guffey, II, FAIA, Charleston, WV. The replacement of missing and broken bricks located within the Tower Enclosure and the restoring of the deteriorated mortar joints shall be completed by Schneider Construction Company, Parkersburg, WV; and the

replacement of missing and broken roof tiles, resecuring loose tiles as required, replacement of missing or deteriorated flashings as needed, providing cement grout where missing at ridge and valley tiles and providing sealant joint replacement when encountered shall be completed by Tri-State Roofing and Sheet Metal Company, Davisville, WV. The start of the aforementioned repairs shall be done as soon as possible so as not to have additional weakening of the Tower and not have increased water infiltration through missing and broken roof tiles. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by David A. Couch and made unanimous by Holmes R. Shaver, did hereby AWARD the bid for an Electronic Voting System for Wood County to Casto & Harris, Inc., Spencer, WV, with the exception of the Canvas Mail Bags, which the County Commission wished to review at a later date. The bid submitted by Casto & Harris, Inc. was proposed by Election Systems & Software, Chicago, IL; Casto & Harris, Inc. is the distributor for Election Systems & Software in West Virginia. The amount of four thousand dollars and 00/100ths cents (\$4,000.00), the cost of the aforementioned one hundred (100) canvas mail bags, will be deducted from the total amount of one hundred twenty-two thousand seven hundred eighty dollars and 00/100ths cents (\$122,780.00) of the bid submitted by Casto & Harris, Inc. Therefore, the amount of one hundred eighteen thousand seven hundred eighty dollars and 00/100ths cents (\$118,780.00) is the total amount of the AWARDED bid at this time. The AWARDING of the bid is pursuant to an Order appearing in Order Book 64, at Page 138 and bearing the date of December 27, 1999, at which time the sole bid was opened and was taken under advisement by the County Commission of Wood County; and further pursuant to a Legal Notice appearing in both local newspapers, The Parkersburg News and The Parkersburg Sentinel, on December 9, 1999 and on December 16, 1999, at which time the County Commission was accepting sealed bids for the aforementioned Electronic Voting System.

Shaver, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Extended Service Plan by and between CWS, P.O. Box 26, Parkersburg, WV, and the County Commission of Wood County, Parkersburg, WV, in regard to the DC-3055 copy machine, Serial Number 37054173, located in the Office of the Prosecuting Attorney for Wood County. The term of the aforementioned Extended Service Plan shall begin on February 20, 2000 and continue through February 19, 2001 which includes one hundred twenty thousand (120,000) copies with any overage at \$.0162 per copy. The charge for the aforementioned Extended Service Plan is in the amount of one thousand eight hundred ninety dollars and 00/100ths cents (\$1,890.00) and includes labor, travel, parts, black toner, black developer and drum.
