Smith, Consulting Engineer for Wood County in regard to the Abandoned Building Ordinance, be compensated on a retainer fee of three hundred dollars and 00/100ths cents (\$300.00) per month. Mr. Smith was hired in March, 1999, as a part-time employee at an hourly rate of pay. An Order was prepared regarding this matter.

Having no further scheduled appointments or business to attend to, the County Commission adjourned at 12:00 Noon.
