IN RE: MINUTES OF MEETING HELD
THURSDAY, DECEMBER 12, 2002

On this date, the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

At 9:30 A.M., the County Commission met with Harvey Rutter and Christian Rutter. After discussion, the County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by K.D. Merritt and made unanimous by Robert K. Tebay, did hereby ORDER that Harvey Rutter be given an extension on the date to clean up his property located on Nicolette Road. On November 4, 2002, the County Commission Ordered that Mr. Rutter have the buildings and debris removed within 45 days; Mr. Rutter now has until July 1, 2003 to repair/remove buildings and debris on his property and is required to keep the property safe and secure. Keith Litton, County Compliance Officer will visit the property monthly and give the County Commission an update. An Order was prepared regarding this matter.

At 10:30 A.M., the County Commission held a hearing in regard to the removal of a co-guardian for Taj Z. Rohr, a minor over the age of fourteen years. Gerald Titus, Attorney; Bob Campbell, Attorney; Rick Bush, Attorney; Taj Rohr, Mary Rohr and Neal W. Rohr were present. The grandparents, Neal Rohr and Mary Rohr are co-guardians for Taj Rohr and are getting a divorce; Taj wants Mary Rohr to be his sole guardian. After hearing the representations and arguments of counsel and the testimony from Taj Rohr, it is hereby ORDERED that the co-guardianship of Neal W. Rohr be terminated and Mary Rohr shall act

as sole guardian of Taj Rohr, and that the bond previously posted be continued. An Order was prepared regarding this matter.


The 11:00 A.M. appointment with Fred Rader from the Mid-Ohio Valley Regional Council, was cancelled.


