## IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: MINUTES OF MEETING HELD THURSDAY, SEPTEMBER 19, 2002

On this date, the County Commission of Wood County met in regular session. They signed orders, invoices and other correspondence.

The County Commission, upon a motion duly made, seconded and passed, approved Erroneous Assessment Applications in regard to personal property for Timothy Ashley – Slate District (2002); Randall S. Cross – Union District (2002); Jackie M. Mullenix – Vienna District (2002); Tommy Schreckengost – Parkersburg City District (2002); Cynthia Greene – Union District (2002); National City Corp. – Parkersburg City District (2002); Mary A. Sullivan –

Clay District (2001); Mike Winters Construction – Lubeck District (1997,1998, 1999, 2000 and 20001); Rudd Equipment – Union District (2002) and for Timothy W. McIntyre – Clay District (2001).

At 10:15 A.M., the County Commission met with Toni Tiano, Grant Consultant and Ginny Conley, Prosecuting Attorney to discuss a grant. After discussion, the County Commission of Wood County upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and passed, did hereby AUTHOTIZE Robert K. Tebay, in his official capacity as President and on behalf of the County Commission, to EXECUTE a letter to the Bureau of Justice Assistance, Rockville, MD, which encloses copies of the proposal for the Reducing Community Gun Violence; Project Safe Neighborhoods Program funds. Funding in the total amount of one hundred seventy-four thousand dollars and 00/100ths cents (\$174,000.00) is being requested. The amount of fifty-seven thousand five hundred dollars and 00/100ths cents (\$57,500.00) will go towards the hiring of a part time Program Coordinator who will expend approximately fifteen (15) hours per week on this project, and for overtime costs for law enforcement officers and the Community Gun Violence Assistant Prosecuting Attorney; the amount of thirty-four thousand dollars and 00/100ths (\$34,000.00) will be used to provide training opportunities for the Program Coordinator, the Community Gun Violence Assistant Prosecuting Attorney and the representatives of the County's law enforcement agencies to attend trainings to enable them to teach the residents of Wood County about the dangers of gun violence; and the amount of seventy-nine thousand five hundred dollars and 00/100ths cents (\$79,500.00) will be used for the community outreach and public education aspect of the program. Funding is being requested for a two-year period. Documentation pertaining to the

Reducing Community Gun Violence: Project Safe Neighborhoods Program is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

At 10:30 A.M., the County Commission of Wood County, opened sealed bids in regard to heating and air conditioning units to be installed on the fourth floor of the Mid-Ohio Valley Board of Health, 211 Sixth Street, Parkersburg, West Virginia. Receipt of the aforementioned sealed bids is pursuant to an ORDER appearing in Order Book 65, at Page 296 and bearing the date of August 26, 2002 at which time the County Commission ORDERED that the bid be let; and further pursuant to a Legal Notice appearing in both The Parkersburg News and The Parkersburg Sentinel on September 3, 2002 and on September 10, 2002, requesting sealed bids. The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay, and passed, did hereby take the aforementioned bids under advisement. An Order was prepared regarding this matter.

At 10:45 A.M., the County Commission met with Ron Salter, Salter and Associates, to discuss a brochure for Wood County. Mr. Salter showed the Commission a color proof of the brochure and made suggestions.

The County Commission of Wood County, upon a motion duly made, seconded and passed, appointed John Sines to the Wood County Planning Commission. Said appointment is pursuant to a letter of resignation from Chuck Rogers and is further pursuant to an Order appearing in Order Book 51, at Page 433 and bearing the date of April 1, 1991, dealing with the procedure policy for appointments to Boards and Authorities. Mr. Sines will be filling the unexpired term of Mr. Rogers, which will expire on December 31, 2004. An Order was prepared regarding this matter.

The County Commission does further ORDER that a copy of the ORDER along with the New Road Name Request Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by K.D. Merritt and passed, did hereby AUTHORIZE Robert K. Tebay, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Certificate of Grant Completion and the Request for Payment in regard to the Governor's Community Partnership Grant Program Number 02-463. The aforementioned grant was in the amount of thirty-five thousand dollars and 00/100ths cents (\$35,000.00) to be utilized for the construction of a sidewalk in Mineral Wells, West Virginia, approximately five thousand three hundred eighty (5,380) feet in length on the east side of West Virginia Route 14 from the Mineral Wells Post Office to the Mineral Wells School. Documentation pertaining to the Governor's Community Partnership Grant Program is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and passed, did hereby ORDER that additional funds in the amount of seven hundred dollars and 00/100ths cents (\$700.00) be placed in the budget allocated to the Wood County Coroner as per his request. The additional funds are being requested for the upcoming Coroner/Medical Examiner Conference to be held on October 28,

29, 30, 2000 in Flatwoods, West Virginia, and to be attended by Michael St.Clair and Brett Pickens. An Order was prepared regarding this matter.

Having no further scheduled appointments or business to attend to, the County Commission adjourned at 12:00 Noon.
