IN THE COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA

IN RE: MINUTES OF MEETING HELD MONDAY, FEBRUARY 28, 2005

PRESENT: RICK MODESITT, PRESIDENT ROBERT K. TEBAY, COMMISSIONER GARY D. DEEM, COMMISSIONER

At 9:30 A.M., the County Commission of Wood County met in regular session. They signed invoices and other correspondence.

At 10:30 A.M., the County Commission met with Toni Tiano, Grant Consultant; Erin Lentz and Diana Williams, Victims Advocates. The County Commission, upon a motion made by Rick Modesitt, seconded by Gary D. Deem and made unanimous by Robert K. Tebay, did hereby EXECUTE a RESOLUTION that AUTHORIZES Rick Modesitt, in his official capacity as President and on behalf of the County Commission, to EXECUTE a Grant Application for the Victims of Crime Act (VOCA) Assistance Program from the Division of Criminal Justice Services through the Office of Military Affairs and Public Safety, State of West Virginia. The aforementioned Grant Application requests funding in the amount of fortynine thousand seven hundred five dollars and 00/100ths cents (\$49,705.00) to enable the continuation of the hiring of a Victims Advocate on a full-time basis, and the hiring of an Assistant Victims Advocate on a contractual basis. The two Advocates will serve victims in the Circuit Court and Magistrate Court as well as on special projects such as C.A.R.E., CRASH Team, S.A.N.E., S.A.F.E. Team, P.E.A.C.E. Program, etc. The Advocates provide victims information on their cases along with other available services with emphasis being placed on the underserved population in regard to rape/sexual assault victims. Matching funds in the amount of twelve thousand four hundred twenty-six dollars and 00/100ths cents (\$12,426.00) are required to be provided by the County, and will be provided as an in-kind match through the additional salary and benefits of the Victims Advocate, and through office space provided by the County at the Magistrate Court Building and the Judicial Building. If funded, the term of the aforementioned Grant would commence on July 1, 2005 and terminate on June 30, 2006. In addition to the EXECUTION of the GRANT APPLICATION, the Special Conditions and Assurances were EXECUTED by Rick Modesitt, in his official capacity as President and on behalf of the County Commission. The aforementioned Grant Application and all pertinent documentation in regard to the Victims of Crime Act (VOCA) Assistance Program Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

At 11:00 A.M., the County Commission met with Sheriff Merritt and Chief Deputy Tom Smith; Vienna Police Chief Steve Stephens and Vienna Mayor David Nohe to discuss an anti-drug campaign for retailers in Wood County. After discussion, the County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby AUTHORIZE a reward in the amount of two hundred fifty dollars and 00/100ths cents (\$250.00) to any person that provides information to area law enforcement agencies that leads to the arrest and conviction of person/persons purchasing products and supplies, and/or operating a methamphetamine lab in Wood County. Posters have been printed and distributed to local law enforcement agencies for their distribution to local retailers within their jurisdiction. An Order was prepared regarding this matter.

Pursuant to an Order appearing in Order Book 51, at Page 433 and bearing the date of April 1, 1991, dealing with the procedure policy for appointments being made by the County Commission of Wood County, the County Commission, upon a motion made by Gary D. Deem, seconded by Rick Modesitt and made unanimous by Robert K. Tebay, appointed Kate Swisher to the Wood County Parks and Recreation Commission (Mountwood Park) to fill the unexpired term of Jack Derr who resigned. Ms. Swisher's term will expire December 16, 2006. An Order was prepared regarding this matter.

The County Commission of Wood County was in receipt of a Letter of Credit from Williamstown National Bank, Williamstown, WV, in the amount of ninety-seven thousand two hundred dollars and 00/100ths cents (\$97,200.00) to insure that nine hundred fifty (950) feet of paving be completed in accordance with the Subdivision Regulations for Wood County in Woodland Falls Subdivision, Area Number Four (4). Woodland Falls Subdivision is located in Union Taxing District and is being developed by Ronald J. Mullenix. The Wood County

Planning Commission set the aforementioned amount of bond at their regular monthly meeting held on March 2, 2005. An Order was prepared regarding this matter.

The County Commission of Wood County, was in receipt of the GRANT AWARD and the fully EXECUTED GRANT PROGRAM CONTRACT BETWEEN THE WEST VIRGINIA DEVELOPMENT OFFICE and the WOOD COUNTY COMMISSION in regard to the Governor's Community Partnership Grant Program. Through the aforementioned Grant Program Contract, the amount of fifty thousand dollars and 00/100ths cents (\$50,000.00) was ALLOCATED to the Young Men's Christian Association (YMCA) for the purchase of equipment for the downtown Parkersburg facility. Receipt of the aforementioned Grant Program Contract is pursuant to an ORDER appearing in Order Book 66, at Page 512 and bearing the date of January 31, 2005, at which time the aforementioned Grant Program Contract was EXECUTED by Rick Modesitt, in his official capacity as President and on behalf of the County Commission. Documentation pertaining to the Governor's Community Partnership Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion duly made, seconded and passed, did hereby ORDER Rick Modesitt, in his official capacity as President and on behalf of the County Commission, to EXECUTE the CERTIFICATE OF APPROVAL on behalf of the Waverly Volunteer Fire Department. The EXECUTION of the aforementioned CERTIFICATE OF APPROVAL AUTHORIZES the said Waverly Volunteer Fire Department to enter into a Volunteer Fire Department Lease and Option Agreement with Republic First National Corporation in an amount not to exceed one hundred thousand dollars and 00/100ths

cents (\$100,000.00) to finance one (1) 1992 Pierce Pumper Tanker and one (1) 1996 American Fire and Rescue Heavy Truck. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, did hereby ORDER that Attorney Dan Marshall be ADVISED to proceed with a financing package in the amount of up to one million five hundred thousand dollars and 00/100ths cents (\$1,500,000.00). Such financing package to be in reference to the renovations of the Judge Donald F. Black Courthouse Annex. An Order was prepared regarding this matter.

Duane Jones from the Wood County Central Telecommunications Center presented to the County Commission of Wood County, a New Road Name Request Form from Paul F. Mohe and Lois A. Mohe, to name the road to their residence. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. Paul F. Mohe and Lois A. Mohe requested the road be named The road to be known as ENGLEWOOD DRIVE is located ENGLEWOOD DRIVE. approximately two thousand (2,000) feet out Butcher Bend Road on the left, in Slate Taxing District, Tax Map 60, Parcel 0C160000. The request by Paul F. Mohe and Lois A. Mohe is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform, nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The County Commission does hereby find that the said request, made in writing, by Paul F. Mohe and Lois A. Mohe, and the approval from the Wood County Central Telecommunications Center, is in proper form and is hereby ORDERED to be filed. NOW, THEREFORE, the County Commission of Wood

County, upon a motion made by Gary D. Deem, seconded by Rick Modesitt and passed, does hereby ORDER that the aforementioned road be named ENGLEWOOD DRIVE. The County Commission does further ORDER that a copy of the ORDER, along with the New Road Name Request Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Gary D. Deem, seconded by Rick Modesitt and passed, did hereby AUTHORIZE Rick Modesitt, in his official capacity as President and on behalf of the County Commission, to sign the Request for Reimbursement in regard to the Victims of Crime Act (VOCA) Grant Number 03-VA-034. Expenditures in the amount of four thousand six hundred ninety-one dollars and twelve cents (\$4,691.12) were incurred by Wood County during the month of January, 2005. However, the Request for Reimbursement is in the amount of three thousand four hundred eighty-four dollars and sixteen cents (\$3,484.16), which represents payment of contractual services provided by Diana Williams, Victims Advocate; payment of contractual services provided by Erin Lentz, Assistant Victims Advocate and payment of cell phone and pager services for Diana Williams. The amount of six hundred fifty-six dollars and ninety-six cents (\$656.96) represents the cash match as required by the aforementioned Grant and reflects the additional hourly rate of Diana Williams not paid through the Grant. The amount of five hundred fifty dollars and 00/100ths cents (\$550.00) reflects volunteer time and the rental of office space at both the Wood County Judicial Building and the Wood County Magistrate Court Building. In addition to the Request for Reimbursement; the Financial Recap; the Monthly Reports from the Victims Advocate and the Assistant Victims Advocate; the Daily Time Records for the Victims Advocate and the Assistant Victims Advocate; the annual Performance Reports of the Victims Advocate and the

Assistant Victims Advocate; and the Project Financial Report are being submitted to the Criminal Justice Services Office in Charleston, West Virginia. Documentation pertaining to the Victims of Crime Act (VOCA) Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, was in receipt of the GRANT AWARD and the fully EXECUTED GRANT PROGRAM CONTRACT BETWEEN THE WEST VIRGINIA DEVELOPMENT OFFICE and the WOOD COUNTY COMMISSION in regard to the Governor's Community Partnership Grant Program. Through the aforementioned Grant Program Contract, the amount of five thousand dollars and 00/100ths cents (\$5,000.00) was ALLOCATED to the Blennerhassett Historical Foundation, Inc. for the Putnam Houser House located on Blennerhassett Island. Receipt of the aforementioned Grant Program Contract is pursuant to an ORDER appearing in Order Book 66, at Page 517 and bearing the date of January 31, 2005, at which time the aforementioned Grant Program Contract was EXECUTED by Rick Modesitt, in his official capacity as President and on behalf of the County Commission. 
