At 9:30 A.M., the County Commission of Wood County met in regular session. They signed invoices and other correspondence.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Gary D. Deem and passed, did hereby EXECUTE a RESOLUTION that congratulates the coaches and team members of the Parkersburg South High School Golf Team for their outstanding accomplishments by being named State Champions. An Order was prepared regarding this matter.

Pursuant to an ORDER appearing in Order Book 67, at Page 234 and bearing the date of November 10, 2005, the County Commission of Wood County did hereby EXECUTE a letter of support addressed to the Parkersburg Housing Authority in reference to the purchase of two (2) houses located on Captain Ames Drive, Parkersburg, West Virginia. The 10:30 A.M. appointment with Ginny Conley to discuss an anti-harassment policy was cancelled.


The 11:00 A.M. appointment with Jim Miracle to discuss the Stevenson House was cancelled.

At 10:55 A.M., the County Commission met with Saebra Pauley to discuss hydrant flushing by Claywood Park Public Service District. Ms. Pauley stated that she has received for the last 17 years, water from Claywood Park Public Service District and they have always flushed the hydrant into her property; she now has a barn there and when they flush the hydrant into their field, it surrounds their barn; they wrote a letter to the PSD informing them they could no longer flush the hydrant into their field; however, they still did; she then went to the manager of the Claywood Park PSD and he laughed in her husband's face and said that rain water could do the same thing; they don't know what to do to get them to stop; there are other places for them to flush the hydrant, it would just take longer. Commissioner Tebay suggested the County Commission write a letter to the PSD. Commissioner Deem suggested she also attend a Board meeting.


Having no further scheduled appointments or business to attend to, the County Commission, upon a motion made by Robert K. Tebay, seconded by Gary D. Deem, adjourned at 12:08 P.M.
