At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

The County Commission, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, approved minutes of July 28, 2005.

The County Commission of Wood County, was in receipt of Grant Adjustment Notice Number Four (4) from the Division of Criminal Justice Services, Charleston, West Virginia, in regard to the STOP Violence Against Women Program Grant Number 03-VAW-008. The aforementioned Adjustment Notice does hereby DEOBLIGATE remaining funds in the amount of three thousand seven hundred fifty-nine dollars and thirty-five cents (\$3,759.35), and consequently CLOSES the aforementioned Grant. Documentation pertaining to the STOP Violence Against Women Program Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County was in receipt of the fully executed COST SHARE AGREEMENT FOR THE OPERATION, MAINTENANCE AND REPAIR PROGRAM by and between the Little Kanawha Conservation District, the Wood County Commission and the City of Parkersburg in regard to the Lower Pond Run Channel. Receipt of the aforementioned fully executed AGREEMENT is pursuant to an ORDER appearing in Order Book 67, at Page 153 and bearing the date of August 18, 2005, at which time Gary D. Deem, in

his official capacity as President and on behalf of the County Commission, was AUTHORIZED to EXECUTE the aforementioned Agreement. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion duly made, seconded and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE an ENROLLMENT ADDENDUM FORM in regard to iTown Communications, Inc. The aforementioned ENROLLMENT ADDENDUM FORM does hereby REQUESTS that the County Commission of Wood County be designated a Local Sponsor under the LOCAL SPONSOR PARTICIPATION AGREEMENT. The said County Commission of Wood County, by previous ORDER, did hereby OBLIGATE the sum of five thousand dollars and 00/100ths cents (\$5,000.00) toward the Feasibility Study. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Gary D. Deem and made unanimous by Rick Modesitt, did hereby AUTHORIZE that the amount of seventy-four thousand dollars and 00/100ths cents (\$74,000.00) be transferred from the Financial Stabilization Fund to the Fort Boreman Fund to cover a check made payable to J.C. Bosley Construction Company, Inc., Mineral Wells, West Virginia, in regard to services rendered in the construction of the Fort Boreman Historical Park. An Order was prepared regarding this matter.

At 10:00 A.M., the County Commission met with Toni Tiano, Grant Consultant and Candice Null, Day Report Center Director. Ms. Tiano discussed a grant application for Drug Court funding. After discussion, County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt, and made unanimous by Gary D. Deem, did

hereby give APPROVAL to Tiano/Knopp Associates, Inc., Parkersburg, West Virginia, Grant Consultants for the County Commission of Wood County, to complete an Application for Drug Court Grant funding over the internet. Such grant funding would provide funds for travel and training of eight (8) individuals in regard to establishing a Court. Such eight (8) individuals would include a coordinator, a judge, a prosecutor, a defense counselor, a treatment representative, a law enforcement representative, a probation representative, and an evaluator and a researcher. An amount of funding is not required at this time. Funding is through the United States Department of Justice, Washington, D.C. An Order was prepared regarding this matter. Ginny Conley, Prosecuting Attorney, was present for this meeting.

At 10:30 A.M., the County Commission of Wood County opened the sole bid for an ANI/ALI Control System for the Wood County 9-1-1 Center located on Core Road, Parkersburg, West Virginia. The sole bid was received pursuant to a LEGAL NOTICE appearing in both local newspapers, The Parkersburg News and The Parkersburg Sentinel, on September 8, 2005 and on September 15, 2005, and further pursuant to an ORDER appearing in Order Book 67, at Page 177 and bearing the date of September 15, 2005, at which time a motion was duly made, seconded and passed, to let the bid for the aforementioned ANI/ALI Control System.

The following is the sole bid received.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, did hereby ACCEPT the aforementioned bid and took the aforementioned bid UNDER ADVISEMENT pending the

review and recommendation from Randall L. Lowe, Director of the Wood County E-9-1-1 Center. Mr. Lowe was present for this meeting.

Mr. Lowe then discussed moving radio equipment from one tower to another. The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Gary D. Deem and made unanimous by Rick Modesitt, did hereby give APPROVAL to the request of Randall L. Lowe, Director of the Wood County 9-1-1 Center, to MOVE radio equipment from the telecommunications tower located on Nicolette Road to the telecommunications tower located at Butcher Bend. The aforementioned telecommunications tower located at Butcher Bend is owned by Alltel and they will not charge the Wood County 9-1-1 Center a fee for location of radio equipment located on their telecommunications tower, according to conversation between Alltel personnel and Randall L. Lowe, Director of the Wood County 9-1-1 Center. An Order was prepared regarding this matter.

At 10:45 A.M., the County Commission met with Adam Krason, ZMM, Inc.; K.D. Merritt, Sheriff; Brian Rader, Holding Center employee; K.L. Dobbins, Holding Center Administrator; Ginny Conley, Prosecuting Attorney and Candice Null, Day Report Center Administrator. They discussed office space and renovations at the Day Report Center.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, did hereby ORDER that ZMM, Incorporated, Charleston, West Virginia, be hired to do the design work and prepare the bid documents in regard to the renovations to the Wood County Holding Center, Parkersburg, West Virginia. An Order was prepared regarding this matter.

At this time, Randall L. Lowe, Director of the Wood County E-9-1-1 Center, ADVISED the said County Commission of Wood County that the aforementioned bid did meet

the bid specifications and recommended that the said County Commission of Wood County AWARD the bid to Tel Control, Inc. TCI. Therefore, the County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, did hereby AWARD the bid for an ANI/ALI Control System for the Wood County 9-1-1 Center to Tel Control, Inc. TCI, Huntsville, Al. An Order was prepared regarding this matter.

At 11:30 A.M., the County Commission met Pat Pickens and other residents to discuss a road name change. After discussion, Duane Jones from the Wood County E-9-1-1 Center presented to the County Commission of Wood County, a New Road Name Request Form from Trannis Smith to change the name of the current road from Ed District Road to Access Road. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. Trannis Smith, along with residents Ronald Smith, John J. Oliver, Delbert R. Phillips, Howard Taylor, Carl Phillips, James Lott, Paul D. Oliver, Kathryn E. Berkhimer, Scott Bailey, Robert B. Dotson, Brian Byers, Melissa Jarvis, Mr. and Mrs. John Dunlap, Edith Rowe, Charles A. Pickens, Pastor Michael S. Horner, Debra Dillon, Mike Dillon, Adam Dillon, Brandy Williams, Jackie E. Carpenter, Christina Carpenter and Kasey Carpenter requested the road be named ACCESS ROAD. The road to be known as ACCESS ROAD is located off Route 14 past Days Inn and Go-Mart under I-77 in Williams Taxing District, Tax Map 200, Parcel OF 110000. The request by the residents is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform, nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The County Commission does hereby find that the said

request, made in writing, by the residents, and the approval from the Wood County E-9-1-1, is in proper form and is hereby ORDERED to be filed. NOW, THEREFORE, the County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, does hereby ORDER that the aforementioned road be named ACCESS ROAD. The County Commission does further ORDER that a copy of the ORDER, along with the New Road Name Request Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby EXECUTE a RESOLUTION that expresses the objections of the said County Commission of Wood County to the approval of the proposed request for an increase by Dominion Hope. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay, and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE the LEASE AGREEMENT by and between THE WOOD COUNTY COMMISSION, Lessor, and THE WEST VIRGINIA SUPREME COURT OF APPEALS, Lessee. The aforementioned LEASE AGREEMENT is in regard to seven thousand three hundred fifty-six (7,356) square feet of office space in the Judge Donald F. Black Courthouse Annex to be utilized by the Family Court Judges as set forth in Chapter 51, Article 2A, Section 20 of the Code of West Virginia. The rental for the aforementioned office space is eight dollars and 00/100ths cents (\$8.00) per square foot; therefore a monthly rent of four thousand nine hundred four dollars and

00/100ths cents (\$4,904.00) and an annual rental of fifty-eight thousand eight hundred forty eight dollars and 00/100ths cents (\$58,848.00). The term of the said lease shall begin on July 5, 2005, and shall terminate on the 30<sup>th</sup> day of June, 2006, unless sooner terminated by either party, and shall thereafter renew automatically for a period of one (1) fiscal year on the 1<sup>st</sup> day of July, 2006, and each succeeding July 1<sup>st</sup> thereafter unless terminated pursuant to the terms as set forth in the aforementioned LEASE AGREEMENT. Through the term of this lease, all property and activities of the Family Court Judges associated with the operation of the Family Court Offices shall be covered by the State Board of Risk and Insurance Management of West Virginia, and the Lessor is therefore held harmless for any damage, injuries, loss or liability arising from said governmental activity; however, Lessor shall maintain a policy of fire and casualty insurance on the structure. An Order was prepared regarding this matter.

At 11:52 A.M., the County Commission met with Ginny Conley to discuss a personnel matter. However, Ginny Conley asked that they discuss the bankruptcy, which is scheduled for 12:15 P.M. now. Sheriff Merritt asked that they wait for Bob Tranquill, who will be here at 12:15 P.M.

Ms. Conley asked for an Executive Session. The County Commission, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, met in Executive Session upon authority granted by the West Virginia Code, Chapter 6, Article 9A, Section 4, Numbers 2, 6 and 7. In attendance was Ginny Conley, Prosecuting Attorney and Candice Null, Director of the Day Report Center. Said Executive Session ended at 12:45 P.M.

At 12:45 P.M., the County Commission met with Jodie Boylen, Assistant Prosecuting Attorney; Bob Tranquill, Chief Tax Deputy; Sandy Edge, Tax Office Deputy; K.D. Merritt, Sheriff and Ginny Conley, Prosecuting Attorney. Ms. Edge explained why they need

assistance with lawsuits, bankruptcies, etc. Mr. Tranquill stated that the Prosecuting Attorney's office has done an excellent job but they have stated themselves that they weren't experts in bankruptcy and sometimes they are unavailable; Andrew Woofter has helped them in the past very quickly. Sheriff Merritt stated they have no problem with the Prosecutor's Office, but when Jodie is tied up they need someone to call and get an answer from quickly. After more discussion, the County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, did hereby AUTHORIZE the amount of two thousand dollars and 00/100ths cents (\$2,000.00) to be set aside for outside legal counsel to assist the Sheriff's Tax Office in regard to bankruptcy cases. The aforementioned AUTHORIZATION is pursuant to a letter from K.D. Merritt, Sheriff of Wood County, requesting such outside legal counsel. In such letter, the Sheriff of Wood County strongly recommends the law office of Richard A. Hayhurst and Andrew C. Woofter, III. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby AUTHORIZE Jack L. Buckley, Maintenance Superintendent, to obtain two (2) quotes on carpet for the rooms located on the third floor of the Wood County Courthouse that will be utilized by Veterans Affairs, the County Commission of Wood County and for the Conference Room upon the renovations of offices vacated by the Sheriff's Tax Office. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby give APPROVAL to the purchase of office furniture for the office of Emergency Management and



the purchase of two (2) chairs for the office of the County Administrator. The total cost for the office furniture for the office of Emergency Management is in the amount of two thousand three hundred eighty-four dollars and fifty-nine cents (\$2,384.59) and the total cost for the chairs for the office of the County Administrator is in the amount of three hundred forty-six dollars and fifty-four cents (\$346.54). The aforementioned office furniture is being purchased through Parkersburg Office Supply, Parkersburg, West Virginia, which has the GSA bid. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to sign the letter addressed to the Courthouse Facilities Improvement Authority, Charleston, West Virginia, enclosing the Monthly Progress Report for the month of September, 2005, in regard to the Courthouse Facilities Improvement Grant Number 54-02-123104. No expenditures were incurred by Wood County during the aforementioned month. Wood County officials met with ZMM, Architects and Engineers, Charleston, West Virginia, to obtain a better understanding of the renovations they wish to do, space configurations, number of offices, cost concerns, etc. ZMM, Architects and Engineers, are working on revised plans that will meet the needs and requirements of all the various functions that will take place at the Wood County Holding Center. Documentation pertaining to the Courthouse Facilities Improvement Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to sign the Request for

Reimbursement, previously signed by Robert K. Tebay as President Pro Tem, in regard to the STOP Violence Against Women Grant Number 04-VAW-006. The Division of Criminal Justice Services would not accept Commissioners Tebay's signature. Everything remains the same as reflected in the ORDER appearing in Order Book 67, at Page 188 and bearing the date of September 29, 2005. Documentation pertaining to the STOP Violence Against Women Program Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Request for Reimbursement in regard to the Court Security Fund Grant Number 05-CS-26. No expenditures were incurred during the period of July 1, 2005 to September 20, 2005. In addition to the Request for Reimbursement, the Project Financial Report and the Grant Progress Report are being submitted to the Division of Criminal Justice Services, Charleston, West Virginia. Documentation pertaining to the Court Security Fund Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to sign the Request for Reimbursement in regard to the Juvenile Accountability Incentive Block Grant Number 04-A-C-265. No expenditures were incurred by Wood County during the month of September, 2005. In addition to the Request for Reimbursement; the Financial Recap; and the Project Financial Report are being submitted to the Criminal Justice Services Office in Charleston, West

Virginia. Documentation pertaining to the Juvenile Accountability Incentive Block Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission was in receipt of a petition from Joseph T. Santer, Attorney for the City of Parkersburg requesting annexation of territories in Parkersburg District to the City of Parkersburg, by minor boundary adjustment. The County Commission set a hearing for November 17, 2005 at 10:30 A.M. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby RELEASE the bond in the amount of forty thousand three hundred dollars and 00/100ths cents (\$40,300.00) in regard to the Worthington Terrace Subdivision developed by H. Pete Headlee of Headlee Builders. The aforementioned amount was a certificate of deposit placed in an escrow account by Mr. Headlee at First National Bank, Parkersburg, West Virginia. The aforementioned H. Pete Headlee completed his subdivision known as Worthington Terrace as required by the Subdivision Regulations for Wood County, and final inspection of the said Subdivision was completed by the Compliance Officer for Wood County. The aforementioned Worthington Terrace is located off Core Road in Parkersburg Taxing District. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby AUTHORIZE that four (4) monitors and four (4) computers be donated to the Wood County Senior Citizens, Parkersburg, West Virginia. The aforementioned computers and monitors were located in the office of the Assessor, and consequently, the Assessor, Steven A. Grimm,

has given approval to the aforementioned donation. An Order was prepared regarding this matter.

Pursuant to an Order appearing in Order Book 51, at Page 433 and bearing the date of April 1, 1991, dealing with the procedure policy for appointments to Boards and Authorities, the County Commission, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did appoint Sgt. R.L. Talkington to replace Sgt. Reginald Patterson, who moved from the area, on the 911 Advisory Board. His term will expire April 30, 2006. An Order was prepared regarding this matter.

Duane Jones from the Wood County 9-1-1 Center presented to the County Commission of Wood County, a New Road Name Request Form from Connie and Michael Shaffer to change the name of the road from Boot Road to RUSTY RUN ROAD. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. Connie and Michael Shaffer, along with residents Sharon L. Farnsworth and Jeffrey J. Stevens requested the road be named RUSTY RUN ROAD. The road to be known as RUSTY RUN ROAD is located 2.186 acres approximately .5 mile from second entrance of Buckner Bend Road off Route 47 in Clay Taxing District, Tax Map 460, Parcel Number 0E2A0000. The request by Connie and Michael Shaffer is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The County Commission does hereby find that the said request, made in writing, by Connie and Michael Shaffer, and the approval from the Wood County 9-1-1 Center is in proper form and hereby ORDERED to be filed. NOW,

THEREFORE, the County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, does hereby ORDER that the aforementioned road be named RUSTY RUN ROAD. The County Commission does further ORDER that a copy of the ORDER, along with the New Road Name Request Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission. An Order was prepared regarding this matter.

Duane Jones from the Wood County 9-1-1 Center presented to the County Commission of Wood County, a New Road Name Request Form from Carl L. Allen to name the road that provides access to his property. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. Carl L. Allen requested the road be named ALLENCREST LANE. The road to be known as ALLENCREST LANE is located approximately two (2) miles south of Lubeck at Sun Valley Road and Route 68 in Lubeck Taxing District, Tax Map 320, Parcel Number 00010000. The request by Carl L. Allen is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The County Commission does hereby find that the said request, made in writing, by Carl L. Allen, and the approval from the Wood County 9-1-1 Center is in proper form and hereby ORDERED to be filed. NOW, THEREFORE, the County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, does hereby ORDER that the aforementioned road be named ALLENCREST LANE. The County Commission does further ORDER that a copy of the ORDER, along with the New Road Name

Request Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Gary D. Deem and passed, did hereby ORDER that the amount of two hundred fifty dollars and 00/100ths cents (\$250.00) be CONTRIBUTED to the Volunteer Action Center. Commissioner Rick Modesitt voted "no". The aforementioned amount to be taken from funds set aside for special projects. An Order was prepared regarding this matter.


The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby ORDER that the said County Commission of Wood County will pay the ten dollars and 00/100ths cents (\$10.00) for each flu shot given to County employees. The flu shots to be administered by the Mid-Ohio Valley Board of Health to County employees on October 26, 2005 from 8:30 A.M. to 9:30 A.M. is in the amount of fifteen dollars and 00/100ths cents (\$15.00). Therefore, County employees are responsible for payment in the amount of five dollars and 00/100ths cents (\$5.00). Family members of County employees will make payment in the full amount of fifteen dollars and 00/100ths cents (\$15.00). A few pneumonia shots will be available in the amount of twenty-five dollars and 00/100ths cents (\$25.00). An Order was prepared regarding this matter.


