IN RE: MINUTES OF MEETING HELD MONDAY, SEPTEMBER 26, 2005

At 9:30 A.M., the County Commission of Wood County met in regular session. They signed invoices and other correspondence.

At 10:30 A.M., the County Commission met with John deBlecourt, Executive Director of Believe in West Virginia. Mr. deBlecourt explained what Believe in West Virginia does for citizens in West Virginia. A copy of a handout is attached to these minutes and should be made a part thereof.

At 11:30 A.M., the County Commission met with Mark King, Sheriff's Department and Sue Patalano, Project Lifesaver. Ms. Patalano and Captain King explained the Wood County Project Lifesaver program and gave a demonstration of the equipment. A copy of a handout is attached to these minutes and should be made a part thereof.

Petitioners Walter A. Ingram, Jr. and Doris I. Ingram, representing themselves, presented to the County Commission of Wood County a Petition to close, vacate and abandon a portion of an unimproved and unused thirty (30) foot right-of-way approximately two hundred ten (210) feet in length situate in Union Taxing District that has not been used for more than fifty (50) years. The said thirty (30) foot right-of-way is situated between Wallace Road and Main Street near State Route 2, and reflected on Tax Map Two Hundred (200). It appearing proper to the County Commission of Wood County, upon a motion duly made by Robert K.

Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, the aforementioned Petition, along with a copy of the tax map reflecting the said unimproved and unused right-ofway, is hereby ORDERED filed and this matter is hereby set for hearing on the 31st day of October, 2005 at 10:30 o'clock A.M. in Room 203 of the Wood County Courthouse, Parkersburg, West Virginia. The Petitioner shall cause Notice of said Public Hearing to be published and served as required by law. An Order was prepared regarding this matter.

Duane Jones from the Wood County 9-1-1 Center presented to the County Commission of Wood County, a New Road Name Request Form from Dawn J. Johnson to name the road that provides access to residences. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. Dawn J. Johnson, along with residents Luinna D. Sherwood and Larene J. Johnson requested the road be named OXAROSA LANE. The road to be known as OXAROSA LANE is located off Meldahl Road, 1.7 miles from Route 68, in Lubeck Taxing District, Tax Map 250, Parcel Number 0006. The request by Dawn J. Johnson is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The County Commission does hereby find that the said request, made in writing, by Dawn J. Johnson, and the approval from the Wood County 9-1-1 Center is in proper form and hereby ORDERED to be filed. THEREFORE, the County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and passed, does hereby ORDER that the aforementioned road be named OXAROSA LANE. The County Commission does further ORDER that a copy of the ORDER, along with the New Road Name Request

Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission. An Order was prepared regarding this matter.

Duane Jones from the Wood County 9-1-1 Center presented to the County Commission of Wood County, a New Road Name Request Form from Linnie Lea Johnson to name a road that provides access to her property. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. Linnie Lea Johnson requested the road be named BREEZEWOOD LANE. The road to be known as BREEZEWOOD LANE is located off Meldahl Road and Oxarosa Lane in Lubeck Taxing District, Tax Map 250, Parcel Number 0L1A. The request by Linnie Lea Johnson is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The County Commission does hereby find that the said request, made in writing, by Linnie Lea Johnson, and the approval from the Wood County 9-1-1 Center is in proper form and hereby ORDERED to be filed. NOW, THEREFORE, the County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and passed, does hereby ORDER that the aforementioned road be named BREEZEWOOD LANE. The County Commission does further ORDER that a copy of the ORDER, along with the New Road Name Request Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission. The request by Lewis and Charlene Mitchell is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The said Request does not interfere with the scheduled readdressing and mapping for the E-9-1-1 Master Street Addressing Guide. Connie June Lynch, along with residents Glen Lough, Clifford E. Richards, Delbert G. Lynch, Jr. and Delbert G. Lynch, Sr., requested the road be named DEL CON DRIVE. The road to be known as Del Con Drive is the first driveway off Love Hill Road in Union Taxing District, Tax Map 300, Parcel Number 00010000. The request by Connie June Lynch is in accordance with Chapter 7, Article 1, Section 3 of the Code of West Virginia, 1931, as amended, which deals, in part, with the County Commission naming or renaming thereof of roads, ways, streets, avenues, drives and the like to assure uniform nonduplicative conversion of all rural routes to city-type addressing on a permanent basis. The County Commission does hereby find that the said request, made in writing, by Connie June Lynch, and the approval from the Wood County 9-1-1 Center are in proper form and hereby ORDERED to be filed. NOW, THEREFORE, the County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and passed, does hereby ORDER that the aforementioned road be named DEL CON DRIVE. The County Commission does further ORDER that a copy of the ORDER, along with the New Road Name Request Form, be certified by the Clerk of the County Commission for entry in the Office of the Clerk of the County Commission.

Wood County Project Lifesaver Caregiver FAQ

Project Lifesaver is a Search and Rescue system using personalized radio transmitters and electronic racking equipment. This transmitter bracelet is worn by individuals with cognitive disabilities, e.g. Alzheimer's, Autism, Down Syndrome, Traumatic Brain Injury, etc. who tend to wander and become confused. Only trained certified Deputies can use the equipment and the Wood County Sheriffs Diffice has 8 Deputies and 1 reserved Deputy certified at this time.

Cost of the Client:

 \$8.50 monthly maintenance fee for battery and wristband replacement (can be waived if client does not have the funds and if we have enough funds)

lient Eligibility:

- Transmitters will be placed with clients ONLY at the request of a legally responsible party
- Must have a cognitive disability, tendency to wander and a primary caregiver providing ongoing, daily hands on care
- Eligibility will be determined by the Project Lifesaver Eligibility Task Force

aregiver Responsibilities:

- Caregiver must check the battery everyday and record on log
- Notify the Sheriffs Office immediately if the battery dies or if there is a problem with client wearing the bracelet or with the tester
- Notify 911 immediately if the client is missing

; the Band Waterproof:

 No it is water resistant. Can be worn in bath, shower, pool, etc. Additional measures can be taken to increase water resistance.

w Easy is it to Remove the Band?

 Wristband is like the hospital ID band. Must be cut off. If client continually worries with it or removes it, there are alternatives such as ankle band, heavier nylon band, leather wrist or ankle bands or creativity.

w Does the Caregiver Replace the Battery?

• The caregiver does not replace the battery. The Sheriffs Office maintains a supply of batteries and they must replace batteries monthly.




