At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

At 9:35 A.M., Shana Modesitt was sworn in as a Deputy Sheriff.

The County Commission of Wood County was in receipt of a check from the State of West Virginia in the amount of eleven thousand eight hundred ninety-nine dollars and ninety-six cents (\$11,899.96) which represents reimbursement to Wood County for expenses incurred during the months of October and November, 2005, in regard to the Mid-Ohio Valley Regional Highway Safety Program Grant Number F06-HS-03 and the Mid-Ohio Valley Regional Highway Safety Program Grant Number F06-HS-03-163/DM06-03-03. Receipt of the aforementioned check is pursuant to an ORDER appearing in Order Book 67 at Page 264 and bearing the date of December 29, 2005, at which time Gary D. Deem, in his official capacity as President and on behalf of the County Commission, was AUTHORIZED to EXECUTE the Request for Reimbursement for the month of October, 2005; and further pursuant to an ORDER appearing in Order Book 67, at Page 268 and bearing the date of December 29, 2005, at which time Gary D. Deem, in his official capacity as president and on behalf of the County Commission, was AUTHORIZED to EXECUTE the Request for Reimbursement for the month of November, 2005. Documentation pertaining to the Mid-Ohio Valley Regional Highway

Safety Program Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County was in receipt of a letter from the West Virginia Division of Culture and History, Charleston, West Virginia, ADVISING the said County Commission of Wood County of the APPROVAL of the Grant Application in the amount of twelve thousand dollars and 00/100ths cents (\$12,000.00) submitted to the West Virginia Records Management and Preservation Grant Program for the purpose of a Filing System for the Office of the Prosecuting Attorney. Receipt of the aforementioned letter of approval is pursuant to an ORDER appearing in Order Book 67, at Page 217 and bearing the date of October 27, 2005, at which time a RESOLUTION was EXECUTED that does hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Grant Application. The aforementioned Grant Application submitted on October 27, 2005, requested funding in the amount of twenty-one thousand one hundred seventy-six dollars and ninety-six cents (\$21,176.96) with a cash match in the amount of two thousand three hundred fifty-three dollars and 00/100ths cents (\$2,353.00), for a grand total of twenty-three thousand five hundred twenty-nine dollars and ninety-six cents (\$23,529.96). The aforementioned letter of approval states that the award of funding is conditional on the submission of the requested photographs and floor plans for the office space, and further states that they urge the County's consideration of manually operated moveable track shelving. The aforementioned letter of approval further states that the County would provide the minimum ten percent (10%) of the total project expenditures. Documentation pertaining to the West Virginia County Records Management and Preservation Grant Program

in regard to the Application on behalf of the Prosecuting Attorney for Wood County is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County was in receipt of a check from the State of West Virginia in the amount of four thousand four hundred thirty dollars and 00/100ths cents (\$4,430.00), which represents reimbursement to Wood County for expenses incurred during the month of October, 2005, in regard to the Juvenile Justice and Delinquency Prevention Grant Number F05-JJV-020. Receipt of the aforementioned check is pursuant to an ORDER appearing in Order Book 67, at Page 246 and bearing the date of November 28, 2005, at which time Gary D. Deem, in his official capacity as President and on behalf of the County Commission of Wood County, was AUTHORIZED to EXECUTE the Request for Reimbursement. Documentation pertaining to the Juvenile Justice and Delinquency Prevention Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County was in receipt of a letter from the West Virginia Division of Culture and History, Charleston, West Virginia, ADVISING the said County Commission of Wood County of the APPROVAL of the Grant Application in the amount of eleven thousand five hundred dollars and 00/100ths cents (\$11,500.00) submitted to the West Virginia County Records Management and Preservation Grant Program for the purpose of purchasing shelving unit systems for the Office of the Circuit Clerk. Receipt of the aforementioned letter of approval is pursuant to an ORDER appearing in Order Book 67, at Page 223 and bearing the date of October 31, 2005, at which time Gary D. Deem, in his official capacity as President and on behalf of the County Commission, was AUTHORIZED to EXECUTE the Grant Application. In accordance with the aforementioned letter of approval,

the said County would provide the minimum ten percent (10%) cash match of the total expenditure. The Grant Application submitted on October 31, 2005, requested funding in the amount of fifteen thousand one hundred thirty-nine dollars and eighty cents (\$15,139.80) with a cash match in the amount of one thousand six hundred eighty-two dollars and twenty cents (\$1,682.20), for a grand total of sixteen thousand eight hundred twenty-two dollars and 00/100ths cents (\$16,822.00). The aforementioned letter of approval does hereby state, "This grant award is conditional on the Circuit Clerk's implementation of the current Records Retention and Disposition Schedule as issued by the West Virginia Supreme Court of appeals and re-issued by the Records Management and Preservation Board." Documentation pertaining to the West Virginia County Records Management and Preservation Grant Program in regard to the Application on behalf of the Circuit Clerk of Wood County is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County was in receipt of a letter from the West Virginia Division of Culture and History, Charleston, West Virginia, ADVISING the said County Commission of Wood County of the APPROVAL of the Grant Application in the amount of ten thousand five hundred dollars and 00/100ths cents (\$10,500.00) submitted to the West Virginia Records Management and Preservation Grant Program for the purpose of purchasing shelving unit systems for the Office of the County Clerk of the County Commission. Receipt of the aforementioned letter of approval is pursuant to an ORDER appearing in Order Book 67, at Page 223 and bearing the date of October 31, 2005, at which time a RESOLUTION was EXECUTED that does hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Grant Application. The Grant Application submitted on October 31, 2005, requested funding in the

amount of ten thousand five hundred ninety-two dollars and ten cents (\$10,592.10) with a cash match in the amount of one thousand one hundred seventy-six dollars and ten cents (\$1,176.10), for a grand total of eleven thousand seven hundred sixty-eight dollars and twenty cents (\$11,768.20). The aforementioned letter of approval states that the County would provide the minimum ten percent (10%) of the total project expenditure. Documentation pertaining to the West Virginia County Records Management and Preservation Grant Program in regard to the Application on behalf of the County Clerk of the County Commission of Wood County is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County was in receipt of a check from the State of West Virginia in the amount of four thousand three hundred forty-five dollars and seventy-eight cents (\$4,345.78) which represents reimbursement to the County for a portion of the salary of the Director of the Wood County Emergency Services and for a portion of the salary of the Secretary of the Wood County Emergency Services for the period of July 1, 2005 to September 30, 2005. Receipt of the aforementioned check is pursuant to an ORDER appearing in Order Book 67, at Page 206 and bearing the date of October 17, 2005, at which time the County Commission of Wood County did hereby EXECUTE a BILLING FOR LOCAL EXPENDITURES. The County Commission of Wood County was in receipt of a check from the State of West Virginia in the amount of forty eight dollars and sixty-eight cents (\$48.68) which represents reimbursement of supplemental expenditures during the period of January 1, 2005 to March 31, 2005; was in receipt of check in the amount of one hundred thirty-five dollars and twenty-three cents (\$131.23) which represents reimbursement of supplemental expenditures during the period of April 1, 2005 to June 30, 2005; and was in receipt of a check

in the amount of forty-eight dollars and sixty-eight cents (\$48.68) which represents reimbursement of supplemental expenditures during the period of October 1, 2005 to December 31, 2005. Documentation in reference to the Corrected Billing For Local Expenditures is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby ORDER that County Commissioners be considered full time employees in regard to the hours as reflected on their checks. The total hours should reflect 86.667 hours per pay period instead of the current 43.334 hours per pay period. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby APPOINT Edward H. Hupp as the BUILDING PERMIT OFFICER for Wood County, which gives authorization to Mr. Hupp to sign building permits issued for areas outside the municipalities of Parkersburg, Vienna, Williamstown and North Hills. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion duly made, seconded and passed, NOMINATED Larry Edwards as a member of the Region V EMS Advisory Commission. Said vacancy is due to the fact that George B. Fox submitted his resignation and is further pursuant to an Order appearing in Order Book 51, at Page 433 and bearing the date of April 1, 1991, dealing with the procedure policy for appointments to Boards and Commissions. The term will expire December 31, 2006. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Gary D. Deem, seconded by Rick Modesitt and made unanimous by Robert K. Tebay, did hereby APPOINT the following members to the Planning Advisory Committee (PAC) in regard to the updating of the Wood County Comprehensive Plan.

The County Commission of Wood County was in receipt of a check from the State of West Virginia in the amount of three thousand five hundred dollars and sixteen cents (\$3,500.16) which represents reimbursement to Wood County for expenses incurred during the month of November, 2005 in regard to the Victims of Crime Act (VOCA) Program Grant Number 05-VA-012. Receipt of the aforementioned check is pursuant to an ORDER appearing in Order Book 67, at Page 265 and bearing the date of December 29, 2005, at which time Gary D. Deem, in his official capacity as President and on behalf of the County Commission, was AUTHORIZED to EXECUTE the Request for Reimbursement. Documentation pertaining to the Victims of Crime Act (VOCA) Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

At 9:54 A.M., the County Commission met with Bob Enoch to discuss signs for Fort Boreman Historic Park. Mr. Enoch discussed price quotes he received for signs for the park. He then informed the Commission he sent a letter to Richard Bentley about membership on the Park Board and he hasn't responded. They then discussed a display case for the historical artifacts related to the Park.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, APPROVED the purchase of six (6) signs for the Fort Boreman Historical Park from SW Resources at a price of four thousand nine hundred ninety-nine dollars and 29/100ths cents (\$4,999.29). The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, did hereby AUTHORIZE Bob Enoch of the Fort Boreman Historical Park Commission to obtain prices for a display case for historical artifacts related to the Fort Boreman Historical Park. Said case would be placed in the Judge Donald F. Black Courthouse Annex. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby APPROVE the naming of the two (2) shelters located at the Fort Boreman Historical Park. Said shelters shall be named, Enoch Shelter and Underwood Shelter, in honor of Bob Enoch of the Fort Boreman Historical Park Commission and former West Virginia Governor Cecil H. Underwood. Both of these gentlemen were instrumental in the formation of the park. An Order was prepared regarding this matter.

At 10:00 A.M., the County Commission met with Toni Tiano, Tiano-Knopp Associates, Inc. to discuss a domestic violence grant. After discussion, the County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby EXECUTE a RESOLUTION that AUTHORIZES Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE a Grant Application for the STOP Violence Against Women Program from the State of West Virginia Division of Criminal Justice Services. The purpose of the Grant Application is to continue a comprehensive domestic violence program which involves the Wood County Prosecuting Attorney's Office, the Family Crisis Intervention Center, the S.A.F.E (Silence Affects Families Everywhere) Team, the Wood County Sheriff's Department, the Parkersburg Police Department, and the Vienna Police Department. The total amount of funds being requested is forty thousand four hundred seventy dollars and 00/100ths cents (\$40,470.00), with the applicable agencies providing a cash match in the amount of fourteen thousand nine hundred sixty-eight dollars and 00/100ths cents (\$14,968.00), for a grand total amount of fifty-five thousand four hundred thirty-eight dollars and 00/100ths cents (\$55,438.00). The Grant Application and all pertinent documentation pertaining to the STOP

Violence Against Women Program from the State of West Virginia's Division of Criminal Justice Services Program is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Gary D. Deem and made unanimous by Rick Modesitt, did hereby EXECUTE a RESOLUTION that hereby AUTHORIZES Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE all necessary documents in regard to the Local Economic Development Assistance Program application for the Worthington Little League in the amount of fifteen thousand dollars and 00/100ths cents (\$15,000.00). Pertinent documentation pertaining to the aforementioned Local Economic Development Assistance Program Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Request for Reimbursement in regard to the Project Heavy Metal Grant Number 03-PSN-02. Expenditures in the amount of nine hundred twenty dollars and forty-six cents (\$920.46) were incurred by Wood County during the month of December, 2005, which represents payment of services provided by Patrick O. Lefebure, Assistant Prosecuting Attorney, in regard to the Project Heavy Metal Grant. In addition to the Request for Reimbursement; the Monthly Report; the Daily Time Sheets for Assistant Prosecuting Attorney Patrick O. Lefebure; the Grant Progress Report; and the Project Financial Report are being submitted to the Criminal Justice Services Offices, Charleston, West Virginia. Documentation pertaining to the Project

Heavy Metal Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion duly made by Robert K. Tebay, seconded by Rick Modesitt and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to sign the Request for Reimbursement in regard to the Victims of Crime Act (VOCA) Grant Number 05-VA-012. Expenditures in the amount of four thousand two hundred fifty-three dollars and ninety-one cents (\$4,253.91) were incurred by Wood County during the month of December, 2005. However, the Request for Reimbursement is in the amount of three thousand five hundred twenty-six dollars and ninety-five cents (\$3,526.95), which represents payment of contractual services provided by Diana Williams, Victims Advocate; payment of contractual services provided by Erin Lentz, Assistant Victims Advocate; and payment of monthly cell-phone expenses incurred by the Victims Advocate. The amount of six hundred fifty-six dollars and ninety-six cents (\$656.96) represents the cash match as required by the aforementioned Grant and reflects the additional salary of the Victims Advocate. The amount of seventy dollars and 00/100ths cents (\$70.00) represents the in-kind match as required by the aforementioned Grant and reflects the hours completed by Kayla Lowers as a volunteer. In addition to the Request for Reimbursement; the Financial Recap; the Monthly Progress Reports from the Victims Advocate and the Assistant Victims Advocate; the Daily Time Records for the Victims Advocate, the Assistant Victims Advocate and the Volunteer; the Annual Reports of the Victims Advocate, the Assistant Victims Advocate; and the Project Financial Report are being submitted to the Criminal Justice Services Office in Charleston, West Virginia. Documentation

pertaining to the Victims of Crime Act (VOCA) Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President and on behalf of the County Commission, to EXECUTE the Request for Reimbursement in regard to the Project Heavy Metal Grant Number 03-PSN-02. Expenditures in the amount of nine hundred twenty dollars and forty-six cents (\$920.46) were incurred by Wood County during the month of November, 2005, which represents payment of services provided by Patrick O. Lefebure, Assistant Prosecuting Attorney, in regard to the Project Heavy Metal Grant. In addition to the Request for Reimbursement; the Monthly Report; the Daily Time Sheets of the Assistant Prosecuting Attorney Patrick O. Lefebure; the Grant Progress Report; and the Project Financial Report are being submitted to the Criminal Justice Services Offices, Charleston, West Virginia. Documentation pertaining to the Project Heavy Metal Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and passed, did hereby AUTHORIZE Gary D. Deem, in his official capacity as President, to sign a letter addressed to the Department of Military Affairs and Public Safety, Charleston, West Virginia, requesting reimbursement for radio batteries in the amount of eight hundred eighty-six dollars and eighty cents (\$886.80) in regard to the Wood County Commission Homeland Security Grant/Homeland Security Grants – Law Enforcement Grant Program. Documentation pertaining to the aforementioned Homeland

Security Grant is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby APPROVE the extension of an annual computer services contract for the Wood County Home Confinement Program. Said contract is with Behavioral Interventions of Boulder, Colorado, and begins on January 16, 2006 and ends on January 15, 2007 at a total price of nine thousand seven hundred fifty dollars and 00/100ths cents (\$9,750.00). The County Commission of Wood County has agreed to fund four thousand eight hundred seventy-five dollars and 00/100ths cents (\$4,875.00) of said amount. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, did hereby ORDER that the bid in regard to the financing of equipment to upgrade field equipment being utilized by the Home Confinement Program of Wood County, be AWARDED to United Bank, Inc., 514 Market Street, Parkersburg, West Virginia, at a term of 24 months at 4.59%. Awarding of such bid is pursuant to an ORDER appearing in Order Book 67, at Page 295 and bearing the date of January 26, 2006, at which time sealed bids were opened by the County Commission of Wood County and taken under advisement upon a motion duly made, seconded and passed. The aforementioned bids and other pertinent documentation pertaining to the financing of equipment to upgrade field equipment being utilized by the Home Confinement Program of Wood County is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by Rick Modesitt and made unanimous by Gary D. Deem, did hereby ORDER that the bid in regard to the purchase of moveable storage racks for ivotronic voting machines be AWARDED to Casto & Harris, Inc., Spencer, West Virginia. The option of the water resistant cover was chosen. AWARDING of such bid is pursuant to an Order appearing in Order Book 67, at Page 289 and bearing the date of January 23, 2006, at which time sealed bids were opened by the County Commission of Wood County and taken under advisement upon a motion duly made, seconded and passed. The aforementioned bids and other pertinent documentation pertaining to the purchase of moveable storage racks for ivotronic voting machines is on file in the Office of the County Administrator. An Order was prepared regarding this matter.

The County Commission, upon a motion made by Robert K. Tebay, seconded by Gary D. Deem and made unanimous by Rick Modesitt, approved minutes from October 20, 2005, October 24, 2005, October 31, 2005 and November 3, 2005. The County Commission, upon a motion made by Gary D. Deem, seconded by Rick Modesitt, approved minutes from October 27, 2005.

The 10:30 A.M. appointment in regard to the Lester Roberts estate was cancelled.

At 11:00 A.M., the County Commission met with Jamie Six, County Clerk, to discuss ballot commissioners. The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by Robert K. Tebay and made unanimous by Gary D. Deem, did hereby receive and FILE a letter from Jamie Six, Wood County Clerk, appointing Tim Miller, Republican Ballot Commissioner, for a term beginning February 1, 2006 and ending on January 31, 2008. Said letter also notes the appointment of Jim Leach as the Democrat Ballot

Commissioner, for a term of February 1, 2006 and ending January 31, 2008. An Order was prepared regarding this matter.

At 11:15 A.M., the County Commission met with Candice Null, Day Report Center; Ginny Conley, Prosecuting Attorney and K.D. Merritt, Sheriff. Ms. Conley needs to know what the status of the renovations is and is concerned about having enough room for the Day Report Center.



Deem, did hereby APPROVE to match funds available to the Wood County Day Report Center from the West Virginia Division of Criminal Justice Services, Community Corrections. The amount of funds available is seven thousand, nine hundred sixty dollars and eighty-three cents (\$7,960.83) and the Wood County matching fund amount is eight hundred eighty-four dollars and fifty-four cents (\$884.54). Said request for matching funds was made by Candice Null of the Wood County Day Report Center. An Order was prepared regarding this matter.




