
At 9:30 A.M., the County Commission of Wood County met in regular session. They signed, invoices and other correspondence.

Mr. Reed also informed the County Commission that the Park Commission had refused an offer from Greg Deem for the work needing to be done on the walking trails in the park. The basis for the refusal was that if Mr. Deem aided in the work on the trails, the trails would be for both walking and the riding of bicycles. Mr. Reed explained to County Commission he told Mr. Deem, that the purpose of the trails for Mountwood Park is for walking and walking only. Mr. Reed also informed the County Commission that the park is about four months from opening.

With no further scheduled appointments or business to attend to, upon a motion by Robert K. Tebay seconded by Rick Modesitt, and made unanimous by Gary D. Deem the County Commission adjourned at 12:10 P.M.
