Tebay, adjourned as the Board of Canvassers at 12:25 P.M. until Thursday, November 16, 2006, at 12:25 P.M. at which time they will certify the results of said election. replacement poll workers is attached to the Order that was prepared and shall be made a part thereof.


With no further scheduled appointments or business to attend to, the County Commission adjourned.


