At 11:00 A.M Terry Moore, Director of the Mid-Ohio Valley Airport, and Tom Crooks, Airport Marketing Director, appeared before the County Commission of Wood County, to provide an update on the new airline service that is due to start the first of May and to give a comfort level of what is going on with the marketing for this in the area.

These meetings will be held in the Office of the County Administrator, Room 205, Wood County Courthouse. An Order was prepared regarding this matter.

On this date, the County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by David Blair Couch and made unanimous by Robert K. Tebay, did hereby AUTHORIZE Robert K.
