with a five (5) year initial term at the rate of three hundred ninety-six dollars and sixty cents

(\$396.60) per year. Said lease shall be subject to all conditions listed in Exhibit A attached to

the Order that was prepared. Information relating to the Happy Valley Flood Mitigation

Project is on file in the Office of the County Administrator.

The County Commission of Wood County, upon a motion made by Rick Modesitt,

seconded by David Blair Couch and made unanimous by Robert K. Tebay, did hereby

EXECUTE a RESOLUTION in which it is Resolved that Robert K. Tebay, in his official

capacity as President and on behalf of the County Commission, is AUTHORIZED to

EXECUTE the COMMUNITY PARTICIPATION GRANT PROGRAM CONTRACT between THE WEST VIRGINIA DEVELOPMENT OFFICE and the WOOD COUNTY COMMISSION in regard to funds allocated to the Kanawha Community Building. The aforementioned funds are in the amount of two thousand dollars and zero cents (\$2,000.00) and are to be utilized to make repairs and improvements to the Kanawha Community Building. The aforementioned Grant Program shall be completed by June 30, 2008 and may only be extended by mutual written agreement of both parties dependent on the reappropriation of funds under the Local Economic Development Assistance Grant Program. Any changes to the scope of the services of the work to be performed, as stated above, shall be mutually agreed upon by and between the West Virginia Development Office and the County Commission, and shall be incorporated in written agreements to this Contract. The aforementioned Contract may be terminated by giving written notice, one party to the other party, and specifying the effective date of such termination. The Grant Contract, executed by Robert K. Tebay, is attached to the Order that was prepared and should be made a part thereof.

With no further scheduled appointments or business to attend to, the County Commission adjourned.
