Tebay, in his official capacity as President and on behalf of the County Commission, to sign the Request for Reimbursement in regard to the Governor's Highway Safety Program Grant Number F08-HS-03-402. The Request for Reimbursement is in the amount of six thousand five hundred twelve dollars and ninety-four cents (\$6,512.94) for the month of August, 2008. The Request for Reimbursement Form, the Program Activity Report, the Project Financial Report, the Time Sheets for the Parkersburg Police Department, the Wood County Sheriff's Department and the Monthly Progress Reports have been submitted. 

At 10:30 A.M., the County Commission attended the HINO Grand Opening in Williamstown, WV.


Having no further scheduled appointments or business to attend to, the County Commission adjourned.


