
On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.



CREDIT CARD USE FOR ASSESSOR AND COUNTY CLERK

Today I have the Mary DePergola here from Elavon, she is the Regional Account Executive. Elavon is the company that processes credit/ debit cards for WesBanco Bank.

A contract was signed in August of 2008 by the President of the County Commission with <u>Official Payments Corporation</u> through United Bank.

We can terminate this contract with 60 days written notice. I am requesting we terminate by sending OPC a letter.


The terms and pricing in this contract are considered proprietary and confidential (see page 5 of the signed contract) so I have provided the contract to the commissioners with the dollar amounts highlighted and feel we would be in violation of this contract if disclosed to others in the room. Rather than call an executive session lets not discuss the terms of the OPC contract.

The fee per transaction for dog tags and recording of various documents in the County Clerk's office would be 50 cents per transaction. This fee would be charged to the customer.

If the Sheriff wants to participate there would be a separate contract for that office and a fee could be established that would be agreeable to him and Elavon (processor for WesBanco). The average collection needs to be calculated to determine a fee that is fair to both parties.

I am impressed with Elavon and I am ready to sign a contract for services to be provided for the Assessor's Office.

I have provided a copy of both contracts to the Prosecutor's Office and I am waiting for a proceed recommendation from that office.
