Also in attendance was Cam Huffman and Joe Campbell of the Wood County Development Authority; Jamie Six, Wood County Clerk; Bob Newell, City of Parkersburg Mayor; Steve Nicely, Dave Ashley, Louis Haer and Dwight Marty of the Mid-Ohio Valley Regional Council Mayor Newell addressed the Commission to explain the status of the proposed Civic Center.
