MONDAY, FEBRUARY 23, 2009

On this date, the County Commission met in regular session. They signed purchase orders, invoices and other correspondence.

The County Commission, upon a motion duly made, seconded and passed, approved minutes from January 29, 2009, February 2, 5 and 6, 2009.

The County Commission, upon a motion made by Rick Modesitt, seconded by Wayne Dunn and made unanimous by David Blair Couch did hereby AUTHORIZE the purchase of replacement firearms (pistols) for the Wood County Sheriff's Office. Said pistols are Glocks and will be purchased from Arrington's 505 Industrial Avenue, Greensboro, North Carolina, at a cost of thirty-one thousand twenty dollars and zero cents (\$31,020.00). Said purchase will be paid for out of the General Fund contingency line item. Said purchase is contingent on the weapons being replaced to be placed in a county auction after the arrival of the new weapons with all the proceeds of the auction being placed in the General Fund contingency line item. An Order was prepared regarding this matter.

At 10:30 A.M., Sheriff Jeff Sandy thanked the County Commission for the work performed by the Maintenance Department. He also thanked them for the approval of the new guns.

At 10:45 A.M., the County Commission met with Nancy Gribble and Vicky Huffman who addressed the County Commission regarding the investigation of their brother's death last year. They stated they have talked to Jason Wharton, Prosecuting Attorney, and he has not

gotten back with them. They also have not gotten much response from the Sheriff's Office. Commissioner Modesitt stated he would contact Jason Wharton to see where he is on the matter. Sheriff Jeff Sandy stated he will look into their end of the investigation. Commissioner Couch stated the County Commission will contact Randy Lowe to get a report from him.

At 11:00 A.M., the County Commission adjourned to sit as the Board of Review and Equalization. At this time they met with Ken and Virginia Cronenberger to discuss their property on Rain Tree Road in Clay Taxing District. After this meeting, they adjourned and met as the County Commission.

At 11:30 A.M., the County Commission met with Dave Ashley from the Wood County Tourist and Convention Bureau who presented an Innovative Programming Grant application for the West Central Soccer Association 2009 West Virginia Soccer Association Open Cup in the amount of \$5,000.00.

The County Commission of Wood County, upon a motion made by Rick Modesitt, seconded by David Blair Couch and made unanimous by Wayne Dunn, did hereby AUTHORIZE the donation of five thousand dollars and zero cents (\$5,000.00) to the West Central Soccer Association (WSCA) to be used towards expenses incurred during the 2009 WCSA Open Cup Soccer Tournament to be held June 5, 2009 through June 7, 2009. Said donation will be paid out of the Innovative Grant Fund of the County. An Order was prepared regarding this matter.

At 11:45 A.M., the County Commission met with Clint Pifer, Floyd Browne Group, who discussed the status of the trail located at Fort Boreman Park.

At 12:30 P.M., the County Commission met with Mayor Bob Newell, in the Office of the Mayor of Parkersburg, West Virginia, upon motion of David Blair Couch seconded by Wayne Dunn and made unanimous by Rick Modesitt, County Commissioners, upon prior adjournment of the regular session convened in EXECUTIVE SESSION upon authority granted by the West Virginia Code, Chapter 6, Article 9A, Sections 4, as amended: WHEREUPON, the said David Blair Couch, one of the Commissioners, Rick Modesitt, President of said Commission, and Wayne Dunn, Commissioner met with Robert Newell, Mayor of the City of Parkersburg. All those present proceeded to discuss the matter for which the said EXECUTIVE SESSION was had, being covered by the West Virginia Code Chapter 6, Article 9A-4, Section 9, of 1931, as amended. The Commission having concluded said discussion, the said EXECUTIVE SESSION adjourned at 1:00 o'clock P.M. An Order was prepared regarding this matter.
