\* - The County Clerk's Fees of \$12.00 shall be deposited into the general fund with \$2.00 dedicated to the operation of the county clerk's office.

\*\* - This 2.20 fee is charged only in Counties where the County Commission has formally created a farmland protection program per WV Code Chapter 8A.

\*\*\* - Right of way with consideration could have WV Housing and property transfer stamp fees as well.

\*\*\*\* - \$1 toward State General Fund; \$15 toward Family Protection Shelter

Information: Deeds, Property Transfer Stamp, County - \$1.10 or \$2.20 per \$1,000, after passage of SB 433 in 2017 permitted to increase above \$2.20 per \$1,000 but not to exceed \$3.30 per \$1,000

areas changed as of June 2017 have been highlighted in yellow

**Note 1:**

Instruments executed or acknowledged in West Virginia must contain the name of the person, and governmental agency, if any, that prepared such instrument at the conclusion of such instrument in the following form: " This instrument was prepared by (name)."

**Note 2:**

WV Code §5A-8-15 provides that the County Clerk shall charge and collect an additional one dollar fee for every document containing less than ten pages filed for recording and an additional one dollar for each additional ten pages of document filed for recording. This fee is added whenever a document is presented for recording.

**Note 3:**

The additional fee for WV Housing of \$20.00 was added for any document that requires property transfer stamps.
