The amounts set forth above as "Total Par Amount of Bonds" for the Projects include estimated Costs of Issuance for the Bonds, which may be funded from the proceeds of the Bonds that would be issued in the aggregate principal amount of Sixty Million Eight Hundred Fifty Thousand Dollars (\$60,850,000). The Board shall also be authorized to pay such Costs of Issuance from its general funds and/or the proceeds of the Bonds, as the Board deems appropriate at the time such Costs of Issuance are required to be paid.

If the Bond issue is approved by the voters of the School District, the Board receives an award or commitment of West Virginia School Building Authority funds (other Federal, State, local or private funds) sufficient, in the Board's reasonable discretion, to complete the Projects and the Bonds proposed hereby are issued, then, in connection with the Projects proposed in this Order: (a) upon the completion of the new Lubeck Elementary School, existing Lubeck Elementary School would be closed as an elementary school, and certain of those students in grades Pre-K through 5 would be assigned to and attend the new Lubeck Elementary School; (b) upon the completion of the new Consolidated Elementary School in the vicinity of Vienna, West Virginia, existing Vienna Elementary School and Neale Elementary School would each be closed as an elementary school, and certain of those students in grades Pre-K through 5 would be assigned to and attend such new Consolidated Elementary School; and (c) upon the completion of the new Consolidated Elementary School in the vicinity of the North End of Parkersburg, West Virginia, existing Criss Elementary School and Emerson Elementary School would each be closed as an elementary school, and certain of those students in grades Pre-K through 5 would be assigned to and attend such new Consolidated Elementary School.
