The amounts set forth above as "Total Par Amount of Bonds" for the Projects include estimated Costs of Issuance for the Bonds, which may be funded from the proceeds of the Bonds that would be issued in the aggregate principal amount of Sixty Million Eight Hundred Fifty Thousand Dollars (\$60,850,000). The issuance of the Bonds is subject to (i)(a) the West Virginia School Building Authority's timely award or commitment of funds to the Board in amounts sufficient, in the Board's reasonable discretion, to undertake and complete the Projects or (b) the availability of other funds to the Board (including Federal, State, local and/or private funds from any source or any combination thereof), in amounts sufficient, in the Board's reasonable discretion, to undertake and complete the Projects and (ii) any and all other necessary actions, approvals and consents required by applicable law.
