An election to authorize continued levies for the fiscal years beginning **July 1, 2028, July 1, 2029, July 1, 2030, July 1, 2031, and July 1, 2032** to a) Construct a New Library in Williamstown, b) pay for the bond used for the building of the South Parkersburg Library, c) pay for the bond used for renovations to the main floor of the Emerson Library, and d) contribute to the general operation of the Parkersburg & Wood County Public Library in the approximate amount of **\$680,292 annually and \$3,401,460** during the term of the levy; according to the Order of the County Commission entered on **9th day of February, 2026.**

That rate of levy in cents per one hundred dollars of assessed valuation on each class of property shall be:
