C-2			WOOD COUNTY COMMISSION LEVY RENEWAL FOR CONTINUED LIBRARY SERVICES MAY 12, 2026 An election to authorize continued levies for the fiscal years beginning July 1, 2028, July 1, 2029, July 1, 2030, July 1, 2031, and July 1, 2032 to a) Construct a New Library in Williamstown, b) pay for the bond used for the building of the South Parkersburg Library, c) pay for the bond used for renovations to the main floor of the Emerson Library, and d) contribute to the general operation of the Parkersburg & Wood County Public Library in the approximate amount of \$680,292 annually and \$3,401,460 during the term of the levy; according to the Order of the County Commission entered on 9th day of February, 2026.
