On this the 1st day of March 1, 1983 it was the unanimous decision of the Wood County Commission to accept Plan #1 of realignment of Magisterial Districts for election purposes only.

Also, on this day representatives from the area Senior Citizens Agency as well as other agencies met with the County Commission to discuss a proposal submitted by the State Commission on Aging of which would consolidate the nine (9) area Agencies on Aging into one (1) unit. Pro's and con's were discussed at this meeting. Mr. Philip Turner Director of the State Commission on aging was present at the meeting to answer questions.






