IN RE: MINUTES OF MEETING HELD MONDAY,  
OCTOBER 6, 1986

At 9:00 this morning the County Commission held a sealed bid opening for the Conversion of approximately 4000 real estate maintenance documents to the West Virginia Computer Assisted Mass Appraisal System. This information must be transferred on to the West Virginia residential/agriculture property record cards for data entry. This pursuant to Legal Notice dated September 16, 1986. The Commission received one bid from Data Collection Services with a bid of \$2.00 per parcel. Commission President Holmes R. Shaver made a motion to take the bid under advisement, Commissioner Dexter L. Buckley, Jr. seconded. A copy of the Order is attached. A copy of the bid is also attached.

At 9:05 the Commission met with Terry Tamburini in regards to the Private Industrial Council. Mr. Tamburini stated that other Counties will be contacted and then the Commission will receive a letter stating those that wish to participate.

At 9:30 the Commission held a sealed bid opening for the furnishment and installation of 10 windows for the second floor office and garage area of the Emergency Services Facility. This is pursuant to the Legal Notice dated September 16, 1986. The Commission received a bid from Big "D" Window and Insulation Company, 1810 Covert Street, Parkersburg, WV. The bid submitted was for \$5,995.00. The second bid was from Colonial Window Systems, Inc., 1000 16th Street, Parkersburg, WV, with a bid price of \$6,900.00. Commissioner Dexter L. Buckley, Jr., made the motion

and it was seconded by President Holmes R. Shaver to take the bids under advisement.

At 10:00 a.m. the Commission held a sealed bid opening for painting of the Mid-Ohio Valley Health Department. This is pursuant to Legal Notice dated September 12, 1986. The first bid the Commission received was from Thomas H. Dotson Painting Company, 127 Nolan Circle, Marietta, Ohio, 45750. The bid submitted was \$17,750.00. The second bid was from Hurricane Painting Company, 414 Duncan Avenue, Bridgeport, WV, 26330. The Wood County Commission agreed to take the bids under advisement. A copy of the Order is attached.

The Commission held hearings on the reappraisal.

Having no further business or appointments, the Commission adjourned at 4:00 p.m.
